## VII. Reports and Presentation:

1. Swaback Planner and Architect – Chris McKibben

Stanley Robbins – maps on the wall, funds for projects, introduce self, clinic is coming for construction, discussion on economic development near the clinic, doctors and nurses coming to the clinic and need to keep them at the clinic, input of laundromat, etc. non-profit native promise started this, need land withdrawal, need the drawing, chapter need to withdraw land for site control, need to have good plan of what is on site, beautiful land here, there is community where water runs through and the community does mostly farming and brings in \$1billion so I see that here that Coppermine is on water, this is Rhonda Harvey from phoenix. Senior center was mentioned.

Rhonda Harvey – introduce self and work for architecture firm, grant was award for Coppermine for economic development, April 24 – to get input from community, layout of housing, one stop shop, 110 acre is the beginning need for land economic development, I would present the different plan and when I got back would like to take back 1 plan and refine the plan

Community – looking at each plan and pick which one they want for Coppermine

Comment – area for hogan, teepee, corral, for demonstration

Comment – take the farm/corral to the outside for option 3

Linda – all options just need to rearrange the locations, from east have recreational area for hiking, horse back riding, etc., for recreational if needs to be taking out then need to go back to permittees, number 3 need to be modified then bring back for review again for approval,

Stan robbins – here the chapter officials work together, community provides their input, need to vote on design of the plot plan for option 1-2-3

Allen – this is selection of plot plan design and its not land withdrawal, resolution is needed for the land withdrawal, select which option you want,

Allen – Option One (3), Option Two (4), Option Three (18)

Allen – any changes to the option one,

Linda – yes there are changes

Stanley – you all want option 3 and recommendations made will be incorporated into the plan then will come back with the revised plan

Community provide input into the 3 different plans.

The plan has the following: Village Green – laundromat, store, gas station, restaurant, office spaces, farmers market, vendor space, retail shops, post office, business, etc... Wisdom Crossings – nursing home facility, senior center, daycare, etc. Living Culture – farm store, greenhouses, garden beds, fields, stables/corrals, community center, youth wellness center, etc. Pocket neighborhood – senior housing, veteran housing etc. Transitional Housing – apartments, housing, etc.

Residential neighborhood – family compound, ranchettes, etc.

Amenities – signage, drainage, landscapes, parks, trails, roundabout art, entry monument, etc.

2. Navajo Land Department H.S.L. – Anjanette Owens & Tully Begay

Tully – introduct and came during planning meeting. Funds for homes like ARPA and each would need homesite. We move the application forward through the process. Grazing official consent on homesite lease. Half mile radius. If no livestock permit holder, then grazing official will note that. Homesite lease application need to go through Fish and Wildife for approval first before going the process. Biological fee is \$20. If approved then we forward application through the process. It takes time to get application reviewed by Fish and Wildlife. Biological Clearances, DCD request, GLD. GLD is flood and trash. Trash around homestead is reason for non-approval. Biological I had mention there are restriction is Red. If grazing official tells you no on homesite lease due to biological restrictions. Need to get approval from grazing official.

Comment – if you applying homesite, you want piece land and don't have grazing permit and don't need signature if no one is using the land

Tully – need to have grazing official determine that, need to consider the water and power infrastructure, need to consider the livestock permit holder using the land,

Guy – livestock permit holder need to take care of their livestock,

Lavern – veterans don't pay fee

Tully - just the \$30 fee

Lavern - \$45 for modification

Tully – yes veteran need to pay, just the waive on \$30 fee, just the fee only, not the annual,

Floyd – fish and wildlife, sensitive area,

Tully - outside the sensitive

Floyd – is there map, tully-yes

Floyd – the cut, we need to know north of highway 89, there is blank for economic development

Tully – I can get information from the map the lat/long of where it ends

Comment – turned application to tuba city so where is the paperwork

Tully – I started 3 years ago with tuba city office, another before that I don't know, plus office is moving, our server went down and they still working on it, office is located at the old Navajo Hopi Land office, behind the chapter house

Comment – we have a copy of the paperwork and can I bring

Tully – call tomorrow. Comment – No answer. Tully – come by office. Comment – office closed.

Tully – we need to watch our words is why staff leave office, in 2016 it states you need to do something about within 2 years and if not application be sent back to you,

Comment – we have been trying. What are your office hours

Tully – 8am to noon and 1pm to 5pm

Linda – map on wall is there an updated map,

Tully – yes I have the map and can print on 8.5 x 11, GIS can print for you

Linda – GIS is as bad, we have paid and haven't received maps,

Tully – bryon bitsusie with GIS

Regular Chapter Meeting Minutes July 17 2023

Stanford – people don't ask questions, if there is dispute over homesite then I will not sign the homesite lease application, 30 minute meeting in window rock with president buu and I don't get my travel expense paid to window rock, there are red tape, zoom meeting is good because grazing official don't get paid much so if they zoom then save travel funds, this homesite lease yes we need to watch our words.

Comment – my inlaws move and travel with their animals, are we entitled to those, there is hardly any grass, people overgrazing, they are nomads, they travel with their sheep

Tully – yes long ago, any structure should have lease, dispute over land is why they did away with this, Comment – I would need submit application. Tully – yes.

Diddie – dispute of homesite lease, going through probate, why is there no asphalt for the chapter parking lot,

Tully – we deal with homesite lease and forward to go through the process, we don't deal with probate.
