Community Health Worker – Susie Shorthair – have information on measle outbreak, there are cases in flagstaff, this measles outbreak is similar to covid, spread by air, its contagious, need to wear mask when going to town, use hand sanitizer. Symptons are fever, running nose, rash, coughing 10 days, measles can cause health complication.

2. Dig Deep – Mike Benally – I came here 2 weeks ago. We are working down the road. I didn't see Coppermine on the list of projects so I came to the chapter. Water to kitchen sink and not to bathroom. Water to cook with and wash hands. No toilets or shower but comes later. During the pandemic, not travel, we hauling water, Coppermine is not in our route but would like to Cistern tank, water pump, sink, solar panel,

Those people that drop off 275 water tanks to see if they want bigger tanks, the criteria is elders, medical conditions,

Dig deep starts about Thoreau and started in Africa. Have travel to west virginia, they have problem with dirty water. Dig deep provide materials and labor. We were doing hot water, water heater is available. Some homes needed weather stripping so assisted homes with it. minimum we would as for is homesite lease. We are help people with homesite lease, have application, assist get signatures from grazing, and will follow through.

Funds have been identified for outhouses. (have exhausted the outhouses funds so till next year) We have 2 water trucks to haul water.

If Coppermine gets on the list, then its every 3 months to haul and refill the water tanks.

Vehicle maintenance will delay water hauling.

Lola – where have you been, as you may know, we don't have nha housing and we have fbfa in the southern Coppermine whom don't have running water, there are homes in west of Coppermine, I have heard of your company, where do you get water from

Mike – flagstaff, page, Shonto, etc. ntua doesn't allow us to haul water because they think we use water for construction, another goal is the water at the church,

Stanford – what about fees for homesite lease

Mike – the individual needs to say they need assistance with survey fees and arch fees.

Mike – elders, medical conditions, veterans, these are priority, also if person has # of children and doesn't have running water,
