RESOLUTION OF THE COPPERMINE CHAPTER

APPROVING BUDGET REVISION TO FUND 15 (PEP FUND) TO HIRE TWO (2) HOME ASSESSOR FOR THE FORMER BENNETT FREEZE AREA IN THE AMOUNT OF \$4,612.00 TO BE TRANSFERRED FROM PROGRAMS AND PROJECTS SPECIALIST BUDGET OF \$33,486.00

WHEREAS:

- Pursuant to 26 N.N.C., Section 3, and 11 N.N.C. Section 10 the Coppermine Chapter is a duly recognized and Certified Chapter of the Navajo Nation Government; and
- Pursuant to 26 N.N.C., Chapter 1, Navajo Nation Chapters, Section 1, Amendment, (B) (1) (2), the Navajo Nation Council delegates to Chapter government authority with respect to local matters consistent with Navajo Law, including custom and tradition allowing chapters to make decisions to govern with responsibility and accountability for community membership; and
- Budget Revision to Fund 15 (PEP Fund) to take funds from FY 2023 Chapter Allocation for Programs and Projects Specialist in the amount of \$4,612.00 to be budget for Two (2) Home Assessor for Former Bennett Freeze Area.
- The following is the budget breakdown to hire Labors for the upcoming Home Assessment:

Two Home Assessor x \$13.00 x160 hrs. =	4160.00	SUTA: \$4160 x 2.41%=	100.00
INSURANCE: 4160. x \$0.80 /100 =	34.00	MEDICARE: \$4160 x 1.45% =	60.00
FICA: \$4160 x 6.2% =	258.00	Total:	4,612.00
