Allen – we received the funds late from Navajo Nation

Allen – we can utilize the local residents, no green wood, help their community, vendor from flagstaff which is pine,

Raymond max was new NHLC director, so funds go through NHLC, DCD, Finance, etc. The funds are still there. If we are certified then funds will be distributed to the chapter. Labor is a need. Next was to contract it out. CLUP may undertake.

With tyler manson working on meeting with president. Trying to get RDC. ARPA funds none went into livestock, etc. feral horses is an issue to get each agency to have crew. Only one crew for the whole Navajo nation.
