Echo Cliff Business Development – Lola – we have been discussing this with stan robbins, swagback development, for development at the clinic, there is going be 200 employees, its going to be nice clinic, south side of the clinic going to have business development, need store, any business development for that area, we need to put it to you all on the business development, if we don't have business development then gap and other chapters can come to in for business development, we need to come up with business plan, right now debra is thinking gift shop, if you really want to get into business, example karen barney they are running the sacred mountain and laundromat in tuba city and chevron so they are making money, this is opportunity for you for business development, the youth indicated need store and improve roads, need business development and come up with your plans, not sure how to address this, maybe go through clup

e. Grazing Official Stanford Fowler information at chapter administration on wool, training at flagstaff, Navajo nation will be buying the wool in window rock, before you go to window rock fill out the wool application in flagstaff, do FSA first, then sell your wool and submit the receipt, its 40cent, lady took over leo watchman, hopefully she has plans, we have been complaining, no water at ram pasture and not sure in other areas, will do some entrapment, olin said he is booked up, so will just work with BIA with entrapment, need rangers present, people that have sheep don't want horses there that its taking grass, sierra club came and stop the entrapment, we try to help people but there are 2 sides, we have been working on reservation wide, a lot of studs and bull which should be in the corral, people are doing adjustment on their animals and some are not, the people that aren't are ruining for us, meeting in flagstaff and BIA want to reduce permit due to overgrazing, they look at overgrazing, BIA will collect all permits and will

assign 15 sheep units, look at animals and reduce, from federal govt, Navajo nation title 3 and federal is 25CFR, if anything needs to be changed then federal goes to Washington but for Navajo nation the changes can be done here, we are over number on dogs, male dogs need to be spade, dogs are eating animals, if you have dogs, don't have no more than 2-3 dogs, animal control don't show up right away, if dog is killing your animal then you can kill it, we only have 1 ranger from Kayenta, if you see dog killing your sheep or animal then you can kill it, doing branding and tally and inspection in other chapters too like kaibeto, etc; I travel around for inspection, I am district grazing official so attend meetings, if your going to run for grazing official make sure you have money and good truck, how do you use in economically way your stock, for cattle you can sell, steer cost \$300-400 which is low, you as producer of sheep its up to you, in past people put rock and sand in the wool to get more weight for more money, so we ruin it for us and cost of wool is low, mix breed for cattle is not good, have one breed on cattle, need orientation, kaibeto wants that, I had policy at ngs, if person mess up then break out the policy, when you become supervisor you go to boot camp for 2 weeks, need CFR for orientation, there are people that are over-grazing,

Lavern – horse roundup for 1st windmill

Stanford – yes, entrapment

Loren – during horse roundup, can we pin up corral

Stanford – if you horses at home, take them to tuba city

Cindy – take care of dogs, best friends will be in gap on July 27-28, contact 435-899-2588 Stanford – ive talk to them about it to come to chapter,
