On behalf of Rye Development, I would like to thank everyone for the opportunity we were given Tuesday afternoon to present additional information regarding our proposed project in Coppermine Chapter.

We appreciated all of the feedback that Tom Chee and I received from community members during the meeting, it helps our team better understand the concerns and limitations a possible project would face.

Rye Development is requesting to schedule an individual proposed project workshop with the Chapter CLUP members and grazing permit holders. The primary purpose of this workshop would be to present the concepts and visions for a pumped hydro storage project within the Coppermine Chapter.

It seems that a work session with your CLUP Committee would be the most appropriate to identify the possible locations for further consideration and future study. We recognize that scheduling this type of a work session may take a week or so to coordinate.

With this request, we would ask that the pending resolution CO-06-049-24 be tabled for consideration for this Monday's Chapter meeting.

Rye does not currently plan to conduct any additional field visits related to this project site until further discussions can occur with the Chapter Leadership (assuming a preferred location can be determined at a Work Session).

Due to the time required to travel to Coppermine by Rye Development staff and consultants, we would ask that we receive a few options for scheduling a work session within the next 2-3 weeks.

In response to your request dated February 27, 2024 requesting permission to cross Navajo Tribal Trust Lands to conduct walk-on field surveys for determining if any cultural/archaeological/biological resources are present, hand boring of soil for initial geotechnical analysis, and a metes and bounds survey. The request is hereby granted for the term of two (2) years for the following areas:

#### Lechee Chapter:

- S/2 of Section 15, Township 41 North, Range 9 East, G&SRM, Coconino County, AZ
- Sections 22, 23, 24, 25, 26, & 35, Township 41 North, Range 9 East, G&SRM, Coconino County, AZ

  injury or property damage that might occur during the course of the field surveys.
- Vehicles will be kept on existing roads and trails. Surface disturbance will be kept to an absolute minimum while conducting the field survey.
- 6. Approval of right-of-way, or a lease or any actual construction is not implied.

Floyd – that map right there is what is in the clup book, fish and wildlife we don't know their stand,

Allen – this resolution is for cease and desist

Alex – yes we need to cease and desist

Comment – oppose the project, there is burial in the area so need to have respect for it Sherry – chuck named lola and other names, I do put on facebook, I want people to know of what the chapter is doing, what chapter officials are doing, hopefully in the future they don't do that again, they took 3 hrs of my time, I don't appreciate of no communication for development, they come at night, they come on 4-track, they even went down to Floyd, you Floyd said to let them in, this buddy system, I don't like how you treat our community, that is fraud, we don't want people come to where I herd sheep, June 3 there was parade, who is given, do it the right way, get people's approval first, hopefully loren and sean that it works well for you and they shouldn't have gone over you,

Lola – I can't remember the exact date, that there were an email for presentation from rye development and Stanford told grazing permit holders of the presentation, then allen came and told the rye to leave, we could of gotten information from them on the project,

Allen – to clarify I didn't approve the meeting,

Stevens – need information, gap community will be apart of this project and are not aware of it, there was meeting that was scheduled but was cancelled, then another meeting cancelled again, that's not the only land, rye development came onto coppermine and said they got approval from varies people,

Debora – the strip is that the endanger species from fish and wildlife

Floyd – yes, they survey it, maybe the project is in the strip,

Lola – we need clarification on the red strip from fish and wildlife, not sure on species, right in the area is where they raise their young at certain time,

Alex – this power plant is put there will they take it back, no its there permanent, if its established for species then they got no business there

Lula – the chapter officials need to communicate with community, power plant has come, the chapter officials use to speak Navajo for the power plant back then, what kind of help did that power plant gave our chapter, none, none was given by the power plant, please chapter officials communicate with community, young kids need to learn Navajo, our people need faith hope, we need to reunite

Sue R – federal can take and take, like copper here in coppermine, there is hole in coppermine, Washington said yes to the companies and they came to our chapter and took the copper, same goes for uranium that took place in Kayenta, grazing official said who is herding sheep out there, Pauline benally is, no one is herding sheep, us elders and I only have 20 sheep and once I get old I probably won't have any sheep, we are on trust land, land its not ours, our parents had many sheep, for us only got 20 sheep,
