6. Coppermine Chapter elected officials will be part of the advisor group to assist the CLUP members.



RESOLUTION OF THE COPPERMINE CHAPTER

AMENDING THE FISCAL YEAR 2023 COPPERMINE CHAPTER CARRYOVER FUNDS IN THE AMOUNT OF \$810,459.45 FOR COPPERMINE CHAPTER AS THE CARRYOVER BUDGET FOR FISCAL YEAR 2024.

WHEREAS:

1. Pursuant to 26 N.N.C., Section 3 (A), and 11 N.N.C., Section 10, The Coppermine Chapter is a duly recognized and Certified Chapter of The Navajo Nation Government, as listed at 11 N.N.C., Part 1, Section 10; and
2. Pursuant to 26 N.N.C., Section 1 (B), The Coppermine Chapter is vested with governmental authority to review all matters affecting the community and to make appropriate correction when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate actions; and
3. At the end of each fiscal year the Coppermine Chapter finds it necessary to make amendments to the previous annual Fiscal Year Navajo Nation Comprehensive Budget to Carryover remaining budget amounts to continue to implement its goals and objectives; and
4. All proposed expenditures of Chapter funds must be contained in a duly-approved Chapter Budget and expended pursuant to the Chapter's written Policies and Procedures and consistent with the applicable Navajo Nation Law; and
5. The remaining balance of the Coppermine Chapter Fiscal Year 2023 Budget is \$ 803,187.25 this amount will be carried over into Fiscal Year 2024 Operating Budget for Coppermine Chapter.
