

Coppermine Chapter membership now delegates the authority to revise appropriated funds budget(s) to the Community Service Coordinator, President, Vice-President, and the Secretary/Treasurer to expedite the release of Gaming revenue to the chapter for services under account 5500 Communications and Utilities; and



AN ACTION SUPPORTING NAVAJO NATION COUNCIL RESOLUTION CO-85-23 TO AMEND THE NAVAJO NATION LOCAL GOVERNANCE ACT TO ALLOW VIRTUAL/HYBRID CHAPTER MEETINGS

WHEREAS:

1. Pursuant to the Local Governance Act, 26 N.N.C. §§ 1 *et seq.*, the Chapter is certified as a political subdivision of the Navajo Nation;
2. Pursuant to the Local Governance Act, 26 N.N.C. § 1(B)(2), the Chapter is allowed to make decisions over local matters;
3. Pursuant to Navajo Nation Council Resolution No. CO-85-23 (CJA-03-24 overriding the President's veto), the Navajo Nation Council approved an amendment to Title 26 of the Navajo Nation Local Governance Act to allow for virtual attendance at Chapter meetings;
4. Pursuant to Section 1(E) of the Local Governance Act, an amendment authorized by the Navajo Nation Council, requires a majority of Chapters to support the amendment prior to the amendment becoming a law in the Local Governance Act;
5. This Chapter Resolution is an action to support or not support the amendment to the Local Governance Act. If a majority of Chapters approve the amendment and the amendment becomes law, this Chapter will consider a separate Chapter Resolution to determine whether this Chapter will allow virtual attendance for the Chapter membership at Chapter meetings. It is understood that virtual attendance is allowed for the chapter membership but not for the Chapter Officials who are required to attend Chapter meetings in-person; and
6. If a majority of Chapters do not support the amendment to the Local Governance Act, the Chapter understands that all Chapter meetings will continue to require the Chapter meeting quorum to consist of registered Chapter members to be in-person.

NOW, THEREFORE, BE IT RESOLVED THAT:

- A. The Chapter supports the amendments to the Local Governance Act identified in Navajo Nation Council Resolution CO-85-23 mentioned in paragraph #3 herein; and
- B. If, and when, a majority of Chapters have supported the same, the Navajo Nation will notify all Chapters when another Chapter Resolution can be considered to allow or not allow virtual attendance for our specific Chapter.

RESOLUTION OF THE COPPERMINE CHAPTER

REAFFIRMING, AUTHORIZING AND SUPPORTING THE COPPERMINE CHAPTER AND THE DISTRICT 1 (ONE) GRAZING COMMITTEE MEMBER TO IMPLEMENT AN INDEFINITE FERAL HORSE, STRAY AND UNCLAIMED LIVESTOCK REMOVAL PROGRAM IN EFFORTS TO IMPROVE THE ECOLOGICAL HEALTH AND PRODUCTIVITY OF THE NAVAJO RANGELANDS FOR PRESENT AND FUTURE GENERATIONS OF THE NAVAJO PEOPLE.

WHEREAS:

1. Pursuant to 26 N.N.C., Section 3 (A) the Coppermine Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., part 1, section 10, and
2. Navajo Nation Council Resolution #CAP-34-98 codifies 26 Navajo Nation code, the Local Government Act, which authorized chapters to implement community-based projects beneficial to the community members; and
3. The Navajo Nation Department of Fish and Wildlife have identified 38,000 horses through an official survey; and
4. Bureau of Indian Affairs/Branch of Natural Resource vegetation studies reveal the land cannot sustain the current permitted number of livestock thus further impacting the range conditions; and
5. The excess population of feral horses and stray livestock are causing deterioration and depletion of resources on the Navajo Nation grazing lands, which includes, wildlife ecological damage, water sources, rangelands, and sacred sites at a rapid speed; and
6. The excess population of stray and feral horses and livestock are over utilizing the range, and causing negative economic impacts on ranchers, farmers, and residents; and
7. Inadequate availability of rangeland forage cause livestock to seek forage within highway Right- of -Ways creating a dangerous driving environment resulting in injury, death and property damage; and
8. Free roaming stallions, bulls and other livestock create a public safety issue for children, elderly and individuals enjoying the outdoor environment; and
9. To encourage volunteer livestock removal for Navajo families with limited resources to market their livestock; and
10. The Coppermine Chapter recognizes there are livestock producers who are willfully in livestock trespass; and
11. The Coppermine Chapter aspires to honor and comply with all Navajo Nation Grazing Regulations and supports Navajo Ranchers and Producers, in attempts to provide an opportunity for economic reciprocity; and
12. The Navajo Nation code, Title 3, Chapter 7, Subsection 1322, Livestock or Equine Roundup Procedures and Requirements sets forth legal regulation.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Coppermine Chapter authorizing the Grazing Official, The Department of Agriculture, The Department of Resource Enforcement, the Department of Fish and Wildlife and the Bureau of Indian Affairs, Branch of Natural Resources, to assist with all livestock removal activities.
2. The Coppermine Chapter encourages humane methods of entrapment to Utilized throughout the livestock removal

program.


3. Right-of Way will be continuously patrolled for livestock in trespass.
4. The Department of Agriculture, The Department of Resource Enforcement shall plan and coordinate voluntary livestock sales.
5. The Navajo Nation shall comply with 3 NNC, Chapter 7, Subsection 1311.
6. The Navajo Nation shall assist transportation for individuals in need of resource to market their livestock upon availability of resources.
7. The implementation of the feral, stray and unclaimed livestock removal program shall in indefinite.

REQUESTING THE BUREAU OF INDIAN AFFAIRS (BIA) BRANCH OF ROADS AND THE NAVAJO DEPARTMENT OF TRANSPORTATION (NDOT) TO REPAIR SEVERE RAIN STORM DAMAGE TO NR 6210 NEAR PORCUPINE MESA AREA BY UTILIZING A BULLDOZER TO REMOVE HEAVY SAND ACCUMULATION AND TO RIP EXPOSED ROCK OUTCROPPING TO IMPROVE SAFE AND CONVENIENT TRAVEL FOR CHAPTER RESIDENTS AND THE GENERAL PUBLIC.

WHEREAS:

1. The Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation government pursuant to Title 26 N.N.C., Part 1 Section 10; and
2. Pursuant to Title 26, N.N.C., Section 1 (B), The Coppermine Chapter is vested with governmental authority to review all matters affecting the Community to make appropriate correction when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate actions; and
3. An intergovernmental agreement and understanding exists for joint partnership and obligations for road maintenance and improvements on system roads within Coppermine Chapter; and
4. NR 6210 is heavily used by western Coppermine residents, health and welfare agencies, emergency vehicles and the safe transportation of students of the area; and
5. A heavy rainstorm in late August washed out the western side of Porcupine Mesa resulting in heavy accumulation of sand and exposing rock outcroppings which a motor grader can not adequately make passable; and
6. Under these circumstances, the only heavy equipment that can improve the conditions will be a bulldozer with the assistance of a frontend loader. The rock outcroppings can be done by a ripping operation.

NOW, THEREFORE BE IT RESOLVED THAT;





A RESOLUTION IN THE MATTER OF SUPPORTING CONTINUED STUDY AND ANALYSIS BY RYE DEVELOPMENT FOR A POTENTIAL HYDROELECTRIC POWER PUMPED STORAGE FACILITY ON THE COPPERMINE CHAPTER.

WHEREAS:

1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C, Section 10, the Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
2. Pursuant to 26 N.N.C., Chapters 1: Navajo Nation Chapters, Section 1., (B) (1) & (2), the Navajo Nation Council delegated to Chapter governmental authority with respect to local matters consistent with Navajo law, including custom and tradition and allows chapters to make decisions to govern with responsibility and accountability to community membership; and
3. The Coppermine Chapter supports planning and economic development activities that can lead to the creation of jobs and improved infrastructure for the Chapter; and
4. Rye Development is a qualified hydroelectric power energy storage development company proposing to study a location on the Coppermine Chapter; and
5. Rye Development is committed to developing and funding a community benefits plan associated with the development of hydroelectric power pumped storage projects; and
6. Rye Development has committed \$20 million associated with Western Navajo Pumped Storage Project No. 2; and
7. Approval of this resolution is limited to support to Rye Development to advance its study process to receive a preliminary permit and does not necessarily endorse full development of the project as of this time.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Coppermine Chapter supports efforts by Rye Development to pursue a preliminary permit to study hydroelectric power pumped storage development on the Coppermine Chapter; and
2. The Navajo Nation should provide written support for the reconsideration of the FERC order to deny the preliminary permits for the Western Navajo No. 1 and No. 2 pumped storage projects.

FURTHERMORE, should it be determined that the project will proceed to the development state, it is understood the Rye Development will commit to \$20 million associated with the Community Benefits Plan associated with the Western Navajo Pumped Storage Project No. 2.




