### RESOLUTION OF THE COPPERMINE CHAPTER

THE COPPERMINE CHAPTER HEREBY REQUESTS THE NAVAJO NATION GENERAL LAND
DEVELOPMENT DEPARTMENT (GLDD) FOR A 250-ACRES LAND DESIGNATION FOR THE COPPERMINE
ECHO CLIFF'S DEVELOPMENT PROJECT ADJACENT TO THE TUBA CITY REGIONAL HEALTH CARE
CENTER'S ECHO CLIFFS CLINIC; FOR A VALUE-ADDED ECONOMIC AND COMMUNITY
DEVELOPMENT WHICH MAY INCLUDE, BUT IS NOT LIMITED, TO THE FOLLOWING PURPOSES:
HOUSING, EDUCATION, ECONOMIC DEVELOPMENT, PLUS HEALTH CARE FACILITIES, PUBLIC
SERVICE USE OR GOVERNMENTAL USE: INDUSTRIAL DEVELOPMENT IS NOT SUPPORTED FOR THIS
AREA; AT THE GENERAL AREA OF 36°18'37"N111°25'47"W COORDINATES.

#### WHEREAS:

- 1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C. Section 10, the Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
- 2. Pursuant to 26 N.N.C., Chapter 1: Navajo Nation Chapter, Section 1. (B) (1) & (20) the Navajo Nation Council delegated to Chapter governmental authority with respect to local matters consistent with Navajo Law, including custom and tradition and allows chapter to make decisions to govern with responsibility and accountability to community membership; and
- 3. On October 1, 2022, Native Promise Inc. received the \$200,000 Rural Business Development Grant (RBDG) to develop the Coppermine Echo Cliffs Business Development Master Plan Project to help the Coppermine Chapter in the Navajo Thaw Region, And the Navajo Nation seized the moment to design and build a complete community inclusive of Navajo economic growth jobs In the retail, vending, grocer, and human services industry.
- 4. On February 2, 2023, we had our first organizing Echo Cliffs Project Zoom meeting, February 17, 2023 zoom meeting Stan Robbins, Native Promise Inc. Vice -Chair was nominated and selected to chair the project, and Lola Smith, Coppermine Chapter Vice-President as Vice Chair.
- 5. On March 10, 2023, the Proposed Coppermine Chapter Echo Cliff's Project was discussed with the Chapter Land Use Planning Committee (CLUPC), Native Promise Inc. introduced to the CLUPC a Federal Master Planning Grant that was awarded to assist The Chapter and Community to do a value-added economic development plan in conjunction with Tuba City Regional Health Care Corporation's 100 acre Echo Cliff's Clinic, located in GPS section 36°18'37"N111°25'47"W coordinates; and
- 6. On March 20, 2023, Brian Cole, of Building Communities, and Stan Robbins, Vice-Chair of Native Promise Inc. gave information to learn more about the history/purpose/activities of this federal grant-funded plan. Chris McKibbin PLA, ASLA; and Rhonda Harvey of SWABACK, Architectural Designer & Planner were on hand to facilitate the discussion; and
- 7. On April 24, 2023, the Coppermine Community met with Native Promise, SWABACK and Building Communities to explain a 5000-foot overview of the Economic Master Plan of other existing clinics of similar size; and
- 8. On June 29, 2023, at a regular chapter meeting SWABACK, Native Promise Inc. and Native Builders presented maps of the

possible location, size, and a list of proposed facilities that may be included in the project plan; and

9. On July 17, 2023, at a regular chapter meeting, Native Promise Inc. and SWABACK provided three maps and asked the chapter members to choose one map they like to see at the next chapter meeting in order to make a decision to begin the GLDD land withdrawal process.

### NOW, THEREFORE BE IT RESOLVED THAT:

- 1. The Coppermine Chapter hereby requests the Navajo Nation General Land Development (GLDD) for a 250-acres Land Designation for the Coppermine Echo Cliff Development Project adjacent to the Tuba City Regional Health Care Center's Echo Cliffs Clinic; for a value-added economic and community development which may include, but is not limited, to the following purposes; Housing, Education, Economic Development, plus Health Care Facilities, Public Service or governmental use. Industrial Development is not supported for this area; at the general area of 36°18'37"N 111°25'47"W coordinates.
- 2. The Coppermine Chapter will follow all Navajo Nation laws and regulations and environmental compliance within the five-year submission to complete the land withdrawal process.
