RESOLUTION OF THE COPPERMINE CHAPTER OF THE NAVAJO NATION

SUPPORTS AND URGES THE NAABIK'IYATI' AND THE NAVAJO NATION COUNCIL TO AMEND THE NAVAJO NATION ELECTION CODE OF 1990- SCHOOL BOARD REAPPORTIONMENT BY AMENDING 11 N.N.C. §§ 2(H), 11, AND 321 (A)(8)

WHEREAS:

- 1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C., Section 10, Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
- 2. Pursuant to N.N.C., Chapter 1: Navajo Nation Chapter, Section 1., (B)(1) & (2), The Navajo Nation Council Delegated the Chapter Government authority with respect to local matters consistent with Navajo Law, including custom and tradition and allows chapter to make decisions to govern with responsibility and accountability to community membership; and
- The Election of Navajo Nation School Board Members is solely an Election matter and must be under the Navajo Nation Election Code and that school board elections are carried out pursuant to the Navajo Nation Election Code.
- The Navajo Nation Council designates and approves all Navajo Nation Election Apportionment pursuant to 11 N.N.C. §9.
- 5. The Navajo Nation School Board Members are defined as "Elected Officials" pursuant to 11 N.N.C. §2(N).
- 6. Currently, the Navajo Nation Election Code 11 N.N.C. §11 designates the Health, Education, Human Services Committee (HEHSC) of the Navajo Nation Council, an Oversight Committee of the Navajo Nation Council, to develop and approve Apportionment for Navajo Nation School Board elections.
- 7. Statutory provision 11 N.N.C.§11, conflicts with 11 N.N.C. §9. 11 N.N.C. §9 affords the Navajo Nation Council the powers and authorities to "designate and approve all Navajo Nation Election Apportionment. However, 11 N.N.C. §11 gives some of the Navajo Nation Council's election apportionment powers and authorities to the HEHSC. The Navajo Nation Council's election apportionment authorities and powers must be fully restored with the Navajo Nation Council.
- 8. The last amendment to 11 N.N.C. §11: Composition of School Board; apportionment for School Board elections, was done on February 13, 2012, through CJA-06-12.
- However, upon the statute, 11 N.N.C. §11's inception to date, the statute has been challenged four times, up to the Navajo Nation Supreme Court, in the following cases:
 - a. Rough Rock Community School v. Navajo Nation, 7 Nav. R. 168 (Nav. Sup. Ct November 08, 1995)
 - b. Rough Rock Community School v. Navajo Nation, 7 Nav. R. 199 (Nav. Sup. Ct. March 14, 1996)
 - c. Rough Rock Community School v. Navajo Nation, 7 Nav. R. 313 (Nav. Sup. Ct. January 09, 1998)
 - d. Ramah Navajo Community School and Borrego Pass Community School v. Navajo Nation, 8 Nav. R. 141 (Nav. Sup. Ct. July 25, 2001)
- 10. Most recently, the statute, 11 N.N.C. §11, was once more challenged in *Ervin Chavez v. Navajo Nation*, WR-CV-55-20 (WR. Dist. Ct March 17, 2021).
- 11. Throughout these cases, the statute has been challenged on the facts that "consultation" was not carried out according to law. The statute has also been challenged on the "criteria" in which the total number of school board

seats represented in each local community school and the chapters represented at each local community school board, is established. The Navajo Nation Supreme Court agreed with the Appellants in each Navajo Nation Supreme Court case concerning school board election apportionment.

- 12. The current statute does not afford the Navajo Voter, fair, clear and concise opportunities to voice their rightful concerns pertaining to the apportionment of school board elections.
- 13. The current statute does not provide, fair, clear and concise procedures, and criteria in developing Apportionment plans for school board elections.
- 14. The Navajo Election Administration, through the Navajo Board of Election Supervisors, are tasked to develop and make recommendations to the Navajo Nation Council all apportionment plans for election purposes pursuant to 11 N.N.C. §321(A)(8).
- 15. The current statute does not provide clear and concise procedures and criteria to the Navajo Election Administration to develop apportionment plans for school board elections and to carry out its statutory required consultation.
- 16. Therefore, due to the statute's, 11 N.N.C. §11, vagueness in providing clear and concise procedures and criteria in the development and presentation of apportionment plans for school board elections, the statute has been challenged up to the Navajo Nation Supreme Court four times and there is another legal challenge pending in the Window Rock District Court. 11 N.N.C. §11 must be amended.

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Coppermine Chapter hereby supports and urges the Naabik'iyati' and the Navajo Nation Council to amend the Navajo Nation Election Code of 1991-School Board Reapportionment by amending 11 N.N.C. §§ 2(H), 11, and 321 (A)(8).
- 2. The Navajo Nation Law affords the Navajo Nation Council the sacred responsibilities to designate and approve all apportionment for Navajo Nation Elections. Navajo Nation School Board members are elected by all eligible Navajo voters during the holding of a Navajo Nation wide primary and general election. Thereby, the Navajo Nation Council must approve apportionment for Navajo Nation School Board elections; 11 N.N.C. § 11: 11 N.N.C. §§ 2(H), 11, and 321 (A)(8) must be amended.

OBJECTS TO THE NAVAJO NATION DEPARTMENT OF DINE' EDUCATION TO ENTER INTO A P.L. 93-638- INDIAN SELF-DETERMINATION CONTRACT WITH THE BUREAU OF INDIAN EDUCATION (BIE) TO "CONTRACT" OUT ALL BIE FUNDED SCHOOLS AND STRONGLY SUPPORTS ALL NAVAJO NATION BIE FUNDED SCHOOLS TO REMAIN AS BUREAU OF INDIAN EDUCATION OPERATED AND P.L. 100-297 GRANT SCHOOLS AND THEIR GOVERNANCE TO REMAIN VESTED WITH THE LOCALLY ELECTED SCHOOL BOARDS

WHEREAS:

- 1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C., Section 10, Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
- 2. Pursuant to N.N.C., Chapter 1: Navajo Nation Chapter, Section 1., (B)(1) & (2), The Navajo Nation Council Delegated the Chapter Government authority with respect to local matters consistent with Navajo Law, including custom and tradition and allows chapter to make decisions to govern with responsibility and accountability to community membership; and
- 3. The Coppermine Chapter community respectfully urges the Navajo Nation President Nez, Speaker of the Navajo Nation Council, and the Navajo Nation Council Delegates to listen to their community people who entrusted them to make decisions to benefit their people and protect the future of our children's education by endorsing our said resolutions; and
- 4. The community members do not support the Navajo Nation Department of Diné Education's (DODE) quest to "contract" all Navajo Nation Bureau of Indian Education funded schools (Bureau operated, Grant and Contract Schools) and to place all governance and control of these schools under DODE.
- 5. Since, 1966¹, the Navajo Nation has been exercising its self-determination by converting Navajo Nation Bureau of Indian Affairs operated schools to Contract or Grant Schools and vesting authorities and control of these schools to locally elected school boards. Thus, the concept of "local control" of our schools were created in the same spirit of Indian Self-Determination.
- 6. The "local control" of our Navajo Nation schools have proven to be effective since its inception in 1966 by educating thousands of our Navajo students and employing hundreds of our own Navajo people to serve as teachers, administrators, and support personnel. In addition, the teaching of our sacred Dine language and culture have been imbedded into our school curriculum at the bequest of the parents and elders of our communities, under the auspices of the "community control" concept. The concept of operating our schools under the spirit of "community control" gives respect and recognition to the thoughts and feelings of our parents and community members who have their children and grandchildren enrolled in our Navajo Nation community control schools; the parents and grandparents of our Dine students know best what they want for their children, not Tribal or Federal Bureaucrats and Politicians.
- 7. Navajo parents and grandparents have fought long and hard, approximately fifty-five years to date, to have their Community Schools operate under the concept of "community control". Many of those leaders and parents in the early stages of creating "community controlled" schools did not speak, understand, or read the English language. However, they had a vision of schools being governed by their own community members, operated by their own

¹ Rough Rock Demonstration School became the first "Community Controlled" Navajo Nation School.

community members and their students taught by their own community members. That vision has been achieved today and it continues to thrive at each of our "locally controlled" Navajo schools.

- 8. The Navajo Nation Department of Diné Education was never statutorily created, in Title 10 of the Navajo Nation Code, to operate Navajo Nation Schools. Thereby, to date, DODE has not operated any school on the Navajo Nation. Instead, DODE was created to support and protect Navajo Nation Community Schools by assisting each school to ensure that they are implementing the concepts of local control and to ensure that the Bureau of Indian Affairs were not unnecessarily and illegally creating obstructions for each school, which would be counter to the laws and regulations of Indian Self-Determination.
- 9. DODE has been using many deceitful tactics and rhetoric to justify their pursuit to take over all Navajo Nation Bureau funded schools and to vest authorities and control with DODE in Window Rock. The community members understand the Department of Dine' Education (DODE) is deceitfully using low test scores to justify their reasons for taking control of Navajo Nation Bureau funded schools and taking away the "local control" from parents and grandparents. A stark reality is that Schools across the United States also have low test scores due to various reasons such as differing curriculum structures, socio-economic conditions of students, funding, and the continuing debate about the appropriate student assessments to use as standards.
- 10. The Navajo Nation Department of Diné Education taking over all Navajo Nation Bureau funded schools and vesting authorities and control with themselves in Window Rock will not improve any student test scores or overall student achievement. Instead, it will create chaos, uncertainty, needless bureaucracies and will significantly impact the cultural and economic dynamics of each community where Community Schools are operated. DODE has never operated a school and the only school type operation, Navajo Nation HeadStart, which is under DODE's responsibilities, continues to fail and is under constant restrictions by the United States Health, Human Services Department due to DODE's inability to effectively operate Navajo Nation HeadStart operations pursuant to established standards and regulations.
- 11. The Coppermine Chapter community members are adamant in keeping the management and control of all BIE Funded Schools (BIE Operated, Grant Schools, and Contract Schools) at the local level. The present "local control" concept and practices of operating Community Schools have proven to be very effective in teaching our students and makes a tremendous socio-economic impact to each served community. Most importantly, the "community control" vision of operating schools have become a reality. The spirit and momentum of having our Navajo Nation Bureau funded schools to operate under the concept and practices of "local control", where parents, grandparents have a direct say in the education of their children and where governance and control are vested in the community people through a locally elected school board must continue.
- 12. Window Rock, big government, must not be allowed to circumvent fifty-five years of progress. The Navajo Nation Department of Diné Education must not be allowed to contract out, through the P.L. 93-638 process any Navajo Nation Bureau funded school and they must not be allowed to steal the governance and control of such schools away from the local communities and centralize them under DODE and other Navajo Nation governmental agencies.

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Coppermine Chapter community hereby objects to the Navajo Nation Department of Diné Education to enter into a P.L. 93-638- Self-Determination contract to take over control of all Bureau Funded schools.
- 2. The Coppermine Chapter community hereby supports the operation of all Bureau of Indian Education Funded Schools such as BIE Operated Schools and Grant Schools to remain governed and controlled by a locally elected school board.
- 3. The Coppermine Chapter community implores the Navajo Nation President Nez, Speaker of the Navajo Nation Council, and the Navajo Nation Council Delegates to listen to their community people who entrusted them to make decisions to benefit their people and protect the future of our children. We, the Diné people do not want our local schools to be controlled by the Department of Diné Education from Window Rock, AZ.
- 4. The Coppermine Chapter demands that the Navajo Nation Department of Diné Education comply with the provisions of Title 10 regarding local controls of schools and help protect our schools, and to stop working against our local Diné people's rights and most importantly jeopardizing the education of our children.

OPPOSING THE NATIONAL PARK SERVICE'S PLANS AND ACTIONS TO LIMIT CONSTRUCTION, MODIFICATIONS AND OPERATIONS OF ANTELOPE POINT MARINA'S DOCKS, RAMPS, SLIPS AND OTHER STRUCTURES PENDING RESUMPTION AND RENEGOTIATION OF AN AGREEMENT BETWEEN THE NAVAJO NATION AND THE NATIONAL PARK SERVICE REGARDING THE GLEN CANYON NATIONAL RECREATION AREA.

WHEREAS:

- 1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C., Section 10, the Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
- 2. Pursuant to N.N.C., Section 1., (B)(1) & (2), The Navajo Nation Council delegated to the chapter governmental authority with respect to local matters consistent with Navajo Law, including custom and tradition to allow the chapter to make decisions to govern with responsibility and accountability to community membership; and
- 3. The Navajo Nation and Federal Agencies entered into the 1970 Quadrilateral Agreement with subsequent Memorandum of Understanding (MOU) and "Bridge Agreements" subject to rights and responsibilities in the planning, development, management and maintenance of the Antelope Point Marina. Accordingly, the Trump Administration allowed the three 50-year agreements to expire on September 10, 2020, with no renegotiation of a new agreement; and
- 4. The Biden-Harris Administration has pledged greater Federal treaty and trust responsibilities through Collaboration, Consultation and a strong working relationship with tribal governments; and
- 5. The drought situation of low water level on Lake Powell presents a dilemma that marinas adapt their ramps, docks, slips, etc. through modifications or new construction to continue operating in a profitable and safe manner; and
- 6. Any National Park Service plan to reduce, reallot or reduce continued operation should be held in consultation with the Navajo Nation; and
- 7. The avenue for a working relationship between the two entities should mutually continue until a new overall agreement is finalized.

NOW THEREFORE BE IT RESOLVED:

1. The Coppermine Chapter hereby opposes and National Park Service's plans and actions to reduce or limit new construction, modifications and operations of Antelope Point Marina's docks, ramps, slips and other structures pending resumption and renegotiation of an agreement between the Navajo Nation and the National Park Service regarding the Glen Canyon National Recreation Service Area.
