- TCRHCC Lena McCabe we met august 12 with Coppermine and bodaway gap. We got our money. Its suppose to be signed off. Hopefully its been sign off so we can start planning. Our CEO last day is in January 2023. We are training our new person. Covid still here and encourage to wear mask. People that tested positive is due to group gathering. People are not wearing their mask in border towns but its required on the Navajo nation.

VIII. Chapter Officials / Council Delegate / CLUP Reports:

1. Council Delegate - Paul Begay – during pandemic I have been attending meetings through phone. Now that in-person is available I'll be attending more in-person meeting. Navajo Nation is the safety place in the United States. If you go to border towns, you can tell who is Navajo because they are wearing their face mask. July – quarterly session. Spring session then summer session then fall session then winter session. We have had meetings on several legislations. Legislations for veterans were discussed. We have received many texts from community to myself and herman daniels. Veterans in 18 western chapters have voiced that no

communication to the veterans. Its why we voted against it. we didn't vote no against veterans but vote for the people. Social media states delegates voted again veterans but there was lengthy discussion. Summer session is over by Friday but report of covid in the office so had adjourned the summer session. Thursday had budget hearing from health, school, different departments with budgets. Health education human service committee I am a member of. Those are the oversight. Discussed the budget for fy22 – fy23. We review many binders. We revisit and make correction. another meeting with human service committee, resource development committee, budget meeting and all that information binders will come before NABI. Then comes before NN council then approval by OPVP. Past weekend, IHS conference and discussed many issues and department of health have attended as well. Human Education Human Service attend to get Information. Chief Manuelito Scholarship has took place as well. Antelope Resort, floating ramp, repair walkway, task force, Floyd is advisor board member long with others. Antelope point the parcel B. they need to give it back to Navajo nation. Interior secretary deb hallway. Parks Service. Yesterday Navajo code talkers recognition in phoenix and same for window rock. Freedom that we enjoy today and we own this to our language. We thankful for our military service, etc. we have received many rain and our prayers been answered. Only person that can declare an emergency is the Navajo nation president. I have told jerry Williams to contact 5 chapters to prepare for emergency. Veterans before pandemic, we have many veterans and provide for questions and answers in march 2022.

Cynthia – western veteran agency did a resolution to improve fy23 budget and was it approved or sent back

Paul – as far summer session, this legislation we didn't receive it. james prepared the budget for fy23 and within the agency…some are still going through revisit stage. Comprehensive budget hearing.

Cynthia – you talk about Antelope point ramp, are they going to make it deeper, they going small ramps and not the longer for the bigger boats

Paul – we are still working on it. have not receive approval from national parks service. Have invited national parks service and have address my concern on the ramp repairs. Superintendent has been reassigned. Take our boats from Antelope Point to Wahweap to launch their boats.

Lola – we met with DCD at Twin Arrows along with you paul begay. We have identified projects for the chapters and some of our projects didn't make the list. Had schedule meeting and it was cancelled then 2nd meeting was cancelled as well. We need to update our projects in the wind system to update our projects listing. We need to meet with pearl and ASC. We don't have AMS and CSC to update the projects in the wind system. I ask and request to have this meeting immediately to update project listings.

Paul – yes we have met and have provide information to the chapters. Another meeting was requested. In about week we will have meeting with pearl on the funding. Im waiting on the date that is open for us. The list for projects can be mention at that meeting.

? – what is mr Z on NABI meeting. He had scary comment on veterans.

Paul – comment on veterans health. There is taboo in Navajo culture. As we grow up, get exposed to western life and some think its okay but for us traditional its not okay. Council can only make recommendations. We don't have the authority to remove him.

? - we community didn't like the way he handle it.

Paul – we talked about it. veterans are our oversight as member of Health education human service.

Jerry Williams – meeting platero and pearl so meeting is set for sept 1 is proposed. Road and dams due to water damage, roads to homes, bus route, which is been requested for wash out, earthen dams, etc.

2. Chapter President - Allen Fowler - will do report at chapter meeting

Chapter Vice-President – Lola Smith – this week I've been busy. I didn't hear about toolbox training till Sunday nite and made it to training at coconino college, page az. Bodaway gap all showed up the staff and officials. We had good technical team from Choice Humanitarian that provide presentation. We need to have another one. They are willing to meet us at college in page. I met with TCRHCC, mr Julius young and has good handle on the infrastructure, working with ntua on power, unsure about the water and are planning on meeting with western pipeline consultants, clinic by gap school is good side clinic and its going to be top notch hospital and will have helicopter pad as well, they will receive over \$1 million to build the clinic, this didn't start couple years but decade, over 200 employees will be needed, jobs will be available to our children, this is only project in the former bennett freeze that is over \$1 million dollars, Tuba city and winslow and Utah Navajo to go 638 so meaning tuba city will overlook and provide medical assistance, there is an overflow at the tuba city hospital and so there is need for another hospital, we are in the design stage and will take year to design it, infrastructure as well been discussed, sewer is been discussed, power is been discussed, water is been discussed, its good size clinic and jobs for our children, we have nurse that graduated, need more housing for our children to work there, more homes into our planning book, need to work on land withdrawal for economic development, we need store, we need fire station, we need to develop the area by the hospital, we need post office, development in the former bennett freeze area.

Paul – there were 3 areas. Dilcon is done. Publebo is next then our clinic is next.

Lola – message from chance foster and she is asking for person to open up their homes to figure how to improve their homes. I need names of people with homes. I need home location. This Saturday, they can assess the homes.

Louise A – weatherization for former bennett freeze.

Allen – we are working on arpa funding.

Esther Addakai – lives in flagstaff. Need home.

Need bathroom for judy sands. There is no outhouse.

Addakai – what about the \$8 million for delegates

Paul – its still in the planning process.

Allen – need members be registered voters

Addakai – im registered voter. Need help with roofing is leaking.

Allen – we get funding by number of voters
