Chris – yes we have computer and will provide training,

Comment – give us the website

b. Council Delegate – Helena Nez-Begay – provide report to the community. Fall session. Legislation amendment for bathroom addition was relook and revised to bathroom renovation, any address for your bathroom addition, included ADA, dr buu signed the legislation, chapter csc for the community, asking community to talk good words only, I met with him on Wednesday, when time is available then i meet with the chapter, tom works for me, kaibeto is having their chapter meeting and dinner, bathroom addition we had 14 bathroom addition in my delegate region, now have 2.5million for bathroom renovation, will distribute this amount to my 5 chapters, only if you really need the bathroom addition, some people that need it may not be available, with Coppermine not certified chapter then needs to work with DCD, veterans, 26 homes were received for

speaker and I have received 5 homes for my region, its only fair that we receive 26 homes, delegate sampson his senior center and had amend his legislation to include our senior center as well, bodaway gap and coppermine were satellite program, elders come to the chapter but services were not provided, I have requested for senior center for coppermine, lechee don't always come out to coppermine, every senior center should be able to home visit of all elders, contracted ended for KPG for livestock and they hire another vendor,

Chris – need homesite lease, disability form hospital, if your getting home then you will not be able to get bathroom renovation, if you have those documents and need that assistance then come see me.

Comment – thank you for the senior center

Comment – thank you, I listen to council session, I hear delegate Helena speak for us, thank you for the senior center, I use to work coconino and would provide firewood, etc, when Helena use to work for senior center and she would send documents to coconino for assistance for elders

Comment - thank you all, our delegate, officials

Comment – talking about home, what about septic tank, is there funding

Helena – arpa funds have funds for septic tank, chapter submitted names, I have work with gap chapter,

Chris – I need list of names for septic tank

Helena - that was project in the past,

c. Chapter President – Allen Fowler Jr. – give my time to lena fowler. Upate on septic tank which in the budget as chapter project for 60 homes for septic cleaning. Its chapter projects so need to obtain 20 to 30 names and work with CSC and he will work on it as chapter project. Funds is received by voters not by CIP, get as many voters as you can. Rest of time to lena fowler.

Lena Fowler, coconino supervisor – its almost 40,000 people that live in coconino county, Kaibab Paiute and san juan Kaibab Paiute, school board which 3 native will on there, school board is important, birth certificate, late birth certificate for new born whom don't get birth certificate right away after birth will fall into late birth certificate, prepare yourself for income tax, social security, Navajo nation have new officials and will continue to work with them, my cell 928-

Comment – election for Coconino is 31%

Comment – how straighten out birth certificate, I have 2 birthdates,

Lena – come to my office and will assist

Comment – I came to your many times

Comment – I got email saying your ballot wasn't counted.

Lena – call the coconino election office, there are a lot of scam,

Lena – my phone is 928-606-4733

Lena – gas, rent that live out there and need assistance, we can fill out application for them,

Deb/Lena – we have propane / wood / electricity is available, if you already got assistance then have to wait for year, we prepare the application and submit to phoenix, due to limited staff it will take time for payment, talk to human health, Mexican sell lemonade and food and tacos so don't buy from them due to been illegal and don't have the proper paperwork, the workers are also illegal, we are looking from those people, these people are human trafficking, especially in phoenix,

- d. Chapter Vice-President Lola Smith thank you for coming, thank you servers, lela was here earlier and they are looking for artist at the Clinic, economic development around the clinic, need youth center / grocery store / etc, we need to bring economic development out here, trying to get documents finalized,
- e. Grazing Official Stanford Fowler beef qualify insurance, had presentation yesterday for lechee and coppermine, permit holders, tonalea had their meeting on Friday, another meeting on Wednesday, white tag, electronic ear tag, need nursing home next, with my western agency I still use zoom meeting, take care of your livestock,
