

Kee - painting, roofing, windows, etc. Materials need to be provided by the homeowner. Person that we have provide assistance like Caroline (electrical work), Sally Tsingine (roof repair), etc.

Sid - have talked to him about the road to his resident and also about gun carrying Wilford - small Indian blood and register vote so can deny them. He turned in all required documents. We can't deny him based on jinii.

I had approved homesite lease but due to location must relocate so need assistance with Archeological Clearances. I had came to chapter for this assistance and it was approved through chapter meeting. Was told the check given to the vendor was canceled.

Wilford - she needs to start the process again at chapter Sid - prepare her documents and submit at chapter meeting
