- g. Utility Assistance Lives here but takes care of family in St George, Utah. His family has the virus and son-in-law passed away recently. Electric bill is high. Emergency Budget doesn't budget for financial assistance but is budget for water, waste, electricity, food, and supplies. Chapter will look into the budget if other Fund Accounts could be used to provide assistance. Can provide assistance up to \$100 which is the usual medical assistance.
