There is few sheep but need to address the cattle. We need to address the drought for Coppermine to address the water and grass. We are told to hurry and finish the drought proposal. Sid – have been Angie's paperwork which indicates # of permit holder and # of livestock. Angie is requesting documents from Calvin. I ask why no visit from Paul or Angie and Gap Chapter says same thing. Lola - this is our land and we need to address from the community.

Linda – clup and lola we had attend meeting but then grazing indicated that its his project. Then told that its job for grazing and chapter officials. It seems like people have jobs so no time. We have the information just need to have means to put it together.

Lola – we need to tackle it. Plan it out. Its just me, Linda, and Floyd that are attending meeting and working on it but its not enough. We need ideas. Need to get Ron Hardy for his assistance and cost estimate. We aren't going to be hauling water all the time but need to look at the waterline project.

Valerie – requesting CHID for house assessment for the FBFA for the material listing which the home visit was completed in September 2019. I had ask for an update from Patrick with CHID and Wilford in October. Today I sent email again to request for an update on the FBFA housing materials for the homes and Wilford indicated that its CHID job to do the assessment and material listing. So I sent Wilford response to Patrick that CHID needs to complete the house assessment and material listing for the FBFA homes. So I am waiting for response from Patrick.

k. 1st Windmill Rodeo - Larry Tsingine: introduced himself and here for the rodeo. My father was away for years then returned then ask for the chapter for land withdrawal for the rodeo ground. In 1948, back then Navajo didn't write things down. Since ray and I are the permit holder so would like for the permit to be transferred to Ray and me from my father's name. Request for the transfer of name. Rodeo is in our family and have World Champ. Its 54 acres. Anybody can use it. We want to set aside to keep the land and build it up. My brother want to start it back up in Coppermine and not in Page or Tuba City. Its a lot of work and funds to start the rodeo at first windmill.

Linda - need to letter of intent, GPS, how to maintain the land, etc. need to work with CLUP and Grazing.

Linda – its a lot of work with CLUP and we are working fast to complete the manual then will be put in front of the community then to RDC. Like cemetery we pick location then people are against the location. We need to put the location in the manual and leave it to Land Department. Homesite lease is less than 1 acre and permit is ½ mile. The only way to move on is to go by Land Department for 1 acre for homesite and ½ mile for permit holder.
