VII. New business/Resolutions:

a. Resolution: Budget Revision Request Approval to transfer fund from Sihasin Multipurpose Building Project of \$200,000 and transfer funds from Sihasin Western Pipeline Project of \$350,000 to be all transferred into Sihasin Powerline Project for 9 Homes for total amount of \$550,000.

Wilford – Scattered Extension Powerline Project for 9 homes and cost is \$547,620.94. Need funds for this project and wasn't funded by CDBG. Light Up Navajo by NTUA and have given the 9 names for selection and had received call from NTUA that only person got selected for the Light Up Navajo Project. But I had called Window Rock and was told that its still been worked on the Light Up Navajo.

Linda - taking money from Multipurpose Building Project and Western Pipeline Project will it change it.

Wilford – yes it will change it

Lola – it will zero out the balances for the Multipurpose Building Project and Western Pipeline Project

Linda – there is need for Multipurpose Building Project and want to keep the funds

Linda – wasn't there funds for survey on the Multipurpose Building Project so I don't know who took it apart Wilford – can do the floor plans, environmental assessments, etc. Estimate for the building is \$2 million.

Sid – there is timeline on the projects. I think Tuba City and Coppermine are the only ones spending Sihasin Funds.

The chapter that aren't spending which the funds will be given to other chapters. Haven't received update report from our Council Delegate.

Sue Yellowman - need to provide information

Valerie – Sihasin Projects: Backhoe Project \$100,000; Powerline Project 3 Clients \$400,000; Multipurpose Building Project \$200,000; Western Pipeline Project \$350,000. Backhoe is in the process been purchased. The powerline project is just waiting for Service Entrance Inspection then funds will be given to NTUA.

Wilford – projects I am planning is road extension from chapter toward west and building extension for weight room and greenhouse.

Lola – people live far from the powerline extension. I don't think LeChee spend that much money on powerline extension for their chapter area. People just live far from power lines. The road extension needs to submit proposal to TTIP with NDOT. The current road has clearances. Went to Road Meeting.

Sid - read the 9 names to the community

Lola - do they live there. If they don't live there then we shouldn't have to spend money on power line projects.

Sue - officials need to push these projects and communicate

Wilford – the funds for the FBFA for \$100,000 is for manpower which needs approval by NHLC. The funds for the FBFA from Escrow \$216,000

b. Sid received an email regarding Presentation during Chapter Meeting on Wood/Coal Burning the Safety Side.

c. Lola - Drought Proposal and have Resolution for the Proposal. This task was assigned Grazing Official. Suggestion from the community for the drought proposal and grazing official doesn't come to chapter nor does he have his meeting. Do you want to continue hauling water.

Sally – is there money for livestock

Sue – Angie Cody had laid out on proposal information. Not for emergency hay money nor grain. We need waterline. Reseeding the land. Livestock to get vegetation. Leupp has already done their drought proposal. Need to get angie back here when calvin isn't available.

Lola – leupp. They fenced in cattle which is similar to Wilford's range mgmt. at leupp they move their cattle from one area to another to another plus no need to haul water since there is waterline. We need to improve the land.

Lola - how much cattle is there

Linda - over 7000

Leonard – we move our cattle around but neighbor's cattle go into our grazing area.

Sid - Chapter Christmas Dinner. Chapter purchase main dish and nuts/candy/fruits for bagging.

e. Road N20 – had invited Henry for update on N20. That road isn't built to our standard. Its an Emergency Road. The state should took road back out after the repair of highway 89 but NDOT stated they would maintain the road. Navajo Police have requested for radar but no funds. Cant do Toll Road.

Lola – road meeting last week and we need to come up with 5 year plan. Which our 1st priority is bus route which is Road 6210 and N21.

Sid - the Road N20 is top priority.

Viola - bus turn out at first windmill

Sid - the incident at Chilchinbeto which occur within the ROW so future bus turn out need to be outside the fence
