f. Leila McCabe – TCRHCC Health Board. Introduce herself to the community and is apart of the health board for TCRHCC. Provide an update on what health board does. Current projects for TCRHCC and upcoming projects for hospital. Ask questions to your doctor when been seen at the clinic and we told doctors to look over their patients instead of giving out medication. Tencer Nez is representing Coalmine on the health board for TCRHCC. Question:

Mae Slim – community its shorter to go to lechee. Hospital just increase building so what about roads. Tencer from Coalmine – the board members consist from Navajo chapters and Paiute. There is road from kaibeto to gap which NDOT will be working on the road. Road from Tuba City to Coppermine is shorter which chapter needs to work on during planning meeting and clup meeting.

g. Ivine Begay - Community Concerns.

Sid – I have received community concerns and ask for documents and have brought police to answer questions. County sheriff = introduced his staff. Drugs in our community. Navajo nation have come to our department to assist with drug problems on the Navajo nation. There is problem with jurisdiction issue. We have arrested 23 related to drug deals in the tuba city and red lake area. We worked several months without letting anyone know. We have had record number of suicides. We have established a mental health training to deal with suicide. To deal with someone dealing with their life. We offer this training to you and its 8hrs long and we can come to bring this training to you. We have had 8 homicide and some were related to drug sale that went bad. This record we don't want to see again. We have had officer shoot and some have occurred in page area. We are still looking for deputy for tuba city area. Lola – during dinner there were party of police officers that came to door and were looking for an individual but were at the wrong location.

Comment – person came to home at 230am and went through the gate and drove past the home to the corral then turn around and went back past the home back out to the gate.

Husband – what is he doing late in the morning

Klemme – I was out there yes and I apologize. Not sure who started horse shooting. I am still looking for my horses. Comment – need to come to home and have respect.

Ivine – there were some shooting and I have shot back for my protection. I have report to police. Need make rounds late at night.

County Sheriff – we come to nation if its life threatening. To safe a life.

Drew Sanders - I agree with what cocoino police have said.

Mae S – get plus code

Wilford - you have vandalized pad locks at rangeland management area.

Klemme – problems were already here before I came. Have had things stolen and shots to my travel trailer.

Lavern – need to respect people and the land. If you are going to go onto people land then you need to let them know that you are going onto their land.

Lola – if you have horses that are unbranded need to be corralled. If your livestock permit isn't been used then its no longer active.

Fern – several concerns that was brought to my attention which she indicated all the concerns to the community. County Sheriff – the common denominator is you Klemme.

Klemme - just wasting your time

Floyd – there was resolution for your home materials which was table because of no resolution, then next time it was table due to not enough vote. People vote only infavor for you but need to have better relationship with the community.

Sid - what the next step.

County Sheriff – you can contact us and will assist if possible

Wilford – I have contact DOJ which person shot him and if you call police and no response so then call the chief, prosecutor.

Herbert – there is problem with you klemme then I would approve your homesite lease. I have heard gun shots. My sister better have heard gun shots. Shirley Scott is permit from Kaibeto and the one from here Coppermine was sold to the Richardson.

Mel johnson – I know what drugs are and how drugs run. I have live in salt lake city for many years and now I have returned to help my family. In the city I had to fence my property and now I still have to fence my land in Coppermine.
