- a. Council Delegate Paul Begay President wants to \$3million into water infrastructure. This is recommendation to split the funds among 24 delegates. Brown and Caldwell do they only work with Western Pipeline. Want chapter to put 3 packages together: water, power, broadband. Need to get broadband and computers since we don't know how long this virus is going to last and need to prepare for school. Need packages ASAP and we are currently working on it. Even if it doesn't have cost for expenditures. Need to do waivers on homesite lease to get housing to the people.
- b. Larry Wallan, PUSD Superintendent Open Online School by August 7. Internet is one of the issues that needs to be work on. August 17 bus will be picking up kids. Parents need to take children to bus stop and will do temperature check and mask will be available then another temperature check at the school. Every student will get Chrome Book, thumb drive, and elementary kids will get IPad. Got email from western agency on grant available for internet. Will have hot spot available and even installed in Chrome book too. Also 11 buses have hot spot on the buses. Will provide hot spots if can get cell service. Till kids come to school. On bus it's going to be hard to do social distancing so going to require mask and will be washing hands before entering the bus and temperature check. Also temperature check throughout the day at school. Temperature check isn't accurate for younger kids. We have \$468,000 from Cares to purchase PPE and Chrome/Ipad, etc. We have added 4 custodian positions. We have started survey and most response was in town and not the rural area. So school will be calling the parents in the rural area. Will provide counselor if any emotional or trauma from virus. Will start up on food services again so working with federal and state regulations.
- c. Community Service Coordinator -

Paul wants 3 packages for power, water, broadband.

Council Delegate's resolution got veto. President resolution might get veto. Waiting on ASC direction for chapters.

LS: paul wants packages that he can hand carry to request for funds.

WL: that's legislative and chapter is under executive. Will give resolutions to paul.

LS: council might waive homesite lease

WL: working on price estimate for the projects
