Coconino County Police -

peeding Enforcement on N20 was issue brought at last meeting. Will do a Speed Trail. Will tell people to slow down. We are in the process to purchase 2 more trailers. Scheduling patrols for N20. We have been issuing citation for speeding. This is an update on Speeding N20.

Recruiting Efforts. We have many open positions. Deputy Sheriffs. Detention Officers/Nurses. Recruitment day to bring up staff.

Question: how offend do you patrol? Try to patrol daily but if other matters occur then patrol less.

L. Glen – substance abuse. We try to address why do people come back to jail and jail and jail. All bookings were under the influence of alcohol and drugs. We are program for 60 days. We have housing for women and men. Substance Abuse Counselor. We require homework. Alcohol awareness. People release from jail and arrest for new item. If person gets out of jail will have 75% to be in jail again. We are 595 beds in jail its almost full. One of our employees is graduate of drugs. Question – are you on with Navajo Nation. Last week my nephew rolled vehicle but was ok so can you work with them.

Glen – they need to be in our custody.

Question: different facility for state or county? Just one Facility.

Juan - we incorporate traditional in the jail

Officer - if you would like to volunteer for teachings in the jail, we are always looking for volunteers

They are willing to buy the scrubber and keep the plan going. Half of the Navajo Nation Budget comes from Navajo Generating Station. If shutdown then there will be limited funds for the Navajo Nation.

Frank: this is not shutdown of coal plant in the U.S. There was 3 shutdown in Texas then also in Battle Mountain. Its cheaper for Natural Gas.

Sid: we don

Brian: is there any study on operation cost, if buyers step away then what happens next, another type of Duane: they study everything. Russell consider this will happen with these buyers. Need to reduce the pollution so keep it open. There are options. Keep it running then go into gasification or solar or wind. Keep it open so Navajo Nation can keep it running. You can table this and get a representative to answer these questions.


