Sid – forward to Planning Meeting Melina Tacheenie – Lola read letter. Wynette read letter.



Linda - CLUP has finish putting together the CLUP Manual and just working on editing. February 5, 2019 at 10am at Chapter Administration which DOJ is attending and look over policy and procedures for Coppermine. Consultant is Floyd Stevens. Chapter Official in attendance is Lola Smith. Grazing Official in attendance is Calvin Begay for that reason is a CLUP Member. The CLUP stipend is not enough to discuss everything. Need to have 2 meetings for CLUP. Will have Strategic meeting after completing the CLUP manual.

Lola – is the Consultant Floyd Stevens still apart of CLUP

Floyd - NHLC paid for consultant \$5 million for the CLUP Manual for 104 Chapters which were complete. Each were paid \$50,000 each. Each CLUP Manual didn't really reflect each community. So there is need for amendment. There was no CLUP committee for some time and some chapter have started up CLUP and some chapters are still without CLUP. Why don't we as Chapters do it ourselves to revised CLUP Manual. There is a lot of work put on CLUP like FBFA, Housing, Economic Development, Rural Addressing, etc. People ask why taking so long because more work is put on CLUP. CLUP are getting paid a lot less than what was paid to the Consultant. CLUP know the situation for their community. The Consultant that was paid didn't know the situation for each community. The work continues. I have completed my job for the chapter and I am aware of some issues that needs to be addressed so continue to provide assistance as a Consultant. There is a lot of meeting. I was paid funds as a consultant and I will be paid remaining amount when CLUP Manual is Approved. ASU student assist with maps. Need to approve the resolution to keep CLUP working on CLUP Manual. Cemetery is an issue which burial can be taking to Page or Tuba City so need input from community.
