Not keeping funds on the reservation but outside the reservation. Its leaving less money for our services. Example the Navajo Nation Sales Tax is tax on the nation for junk food. We need to build the Navajo Nation. At Change Lab, we have business management, financial

classes, marketing, etc. We coach business at the start up to build and grow. Our hope is small business to display their goods which provide rental spaces. Its hard to get business site lease on the Navajo nation. There are some have no zoning. Place where business can address their place. Artist residency. Public art. Artist can have free art supplies for one year for start up. Invite to may 17 for open house which is behind Dennys in Tuba City.

Marie – do you help person that has business at home. Yes.

Wilford – do you use live fund. No sure what that is.

Wilford – its \$100 and get help using business plan.

Marsha - we use Build Navaio.

Larson – if you register for the Navajo nation which pay taxes to Navajo nation. So do you pay taxes to Navajo Nation.

Marsha – yes you have pay taxes to Navajo Nation, Town, and Uncle Sam.

Marsha – do you want the taxes to help you

Larson – I pay taxes elsewhere at 10%. So if I get business then I have to pay Navajo Nation and US.

Marsha – yes you end up pay taxes for everything.

Paul - \$40 million is revenue for NGS and Kayenta. Will definitely feel it next year but not this year. Will see recommendation in consolidating smaller chapters and cutting personnel with the Navajo Nation. Vote was 9 to 11 for the NGS. Ask the federal government to intervene. Renewable energy. Low revenue will be an issue. Give us time to adjust. Natural gas. There were jobs but no longer. There were 3 shifts working 24 hours a day and now no more. Most employees moved to Phoenix with NGS.
