Appropriation Act – authorizes the process of developing and implementing the annual Navajo Nation comprehensive budget. The Appropriation Act states that the Navajo nation government has a fiduciary responsibility to account for public funds, manage finances wisely, and plan for adequate funding of services desire by the Navajo people including the provision and maintenance of public facilities. Melvin – cemetery concern. Cost in page is \$1000 for funeral plot. What is the cost here in Coppermine. Sid – no cost. People are opposing the community cemetery location.

- e. Council Delegate have been on travel since last Sunday. After chapter meeting then Im headed to window rock. Health education human services which oversee hospital, schools, veterans, etc. oversee the elderly to college. Budget session started July 20-22. If the budget don't calculate then is given back to re-calculate to get funds matching then we revise the budgets. NABI budget session which is combination of RDC and HEHS and etc. Navajo Nation Council budget session was on Tuesday to finalize on Tues to Friday during the Navajo nation fair. Aug 15 came to Bodaway Gap to hear more on Former Bennett Freeze Area community resident. There is no windmill in the cedar ridge area. Congressman wasn't aware of the FBFA situation. Legislation to not close the onear office. Update on road improvement on Road N21. Drought planning for Navajo nation. Situation at Cameron last year with the horses does that have to take place in order to do something about the drought. Requesting for emergency drought but was never address. Power plant will be closed before December 22. 399 have been offered jobs and 31 decline job offer. There is 108 waiting for job offer at the plant. 268 people are onsite. Navajo contractors was open to them but not one Navajo contractors applied. Decommission activity. All work is to be done without the extension lease. Kayenta mine there is no hourly salary personnel. The reclamation will begin at Kayenta mine. There be Coal available for Navajo nation for heating. Farmington at san juan college cloud peak energy that was purchased by NTEC so meeting with NTEC on Sept 13, 2019 at 10am. Impact aid for Navajo nation.

Lola – impact aid for NM which is the same for page area too. Impace aid is given to property tax for the city of page. For instance, in flagstaff they assist the students a lot and for page they don't do that for assistance to the students.

Paul – impact aid will have meeting in phoenix soon and its already discussed in NM. Bordertown need to look into the impact aid which is one of the task. Kee allen begay and I which represent Arizona.

Wilford – Tom O'Hallerance which we met in Cameron and Coppermine Chapter was the only chapter that submitted resolution and project document for FBFA. 62 homes which names were given from IHS that is the project to request funds for the bathroom addition for the FBFA. mostly discussed for home renovation, new home, etc which is why chapter are requesting for a lot of funds. provide information on the western pipeline from lechee to Cameron. These are the 2 priorities for Coppermine the bathroom addition and waterline project.

Paul – had requested at Gap for another meeting for chapters to submit project for the FBFA. some chapters aren't pushing. Tom O'Halleron stated if only one chapter requesting funds isn't good enough but better to get projects from the 9 chapters which he can take the projects to Washington to request for funds. I have assigned Angie to work with chapters to submit projects for their FBFA.

Viola – the road improvement near the first windmill which work was done but not complete and its concern when it becomes muddy and icy roads. Drought please voice for Coppermine. The road N20 has closed access for the East livestock to get to the first windmill. The livestock doesn't use the under passage.

Paul - they are preparing the road for future project.

Lola – paul babbitt need to meet with on the quadrilateral agreement. Home in page and lechee can continue their current water. the western pipeline is needed for the people from Coppermine to Cameron and not giving to LeChee or page.

Paul – the water treatment plant is used by the Lechee. Need for bigger water pipeline. Page stated that Navajo nation need to purchase water treatment center for lechee.
