



Dear Mr. Whitehair:

The Tuba City Office of Environmental Health and Engineering has received funding for several IHS scattered projects. The purpose of these projects is to serve homes within the various Chapters of the Western Agency, with a potable water line connection and septic tank/drain field installation. Several homes within the Coppermine Chapter have been included on the project. Seven (7) of those homes will require bathroom additions before our office is able to provide services. Unfortunately, the project does not receive funding to construct bathroom additions.

Therefore, it is requested that the Coppermine Chapter help those in need of a bathroom addition by providing the material and/or labor to build an addition. The bathroom additions must be completed before the Indian Health Service can provide services to those homes which require bathroom additions. Those on the project who do not receive a bathroom addition will only receive a kitchen sink from IHS, instead of a fully plumbed bathroom. Any assistance the Chapter could provide would be greatly appreciated.





RESOLUTION OF THE COPPERMINE CHAPTER

**REQUESTING THE 115TH CONGRESS OF THE UNITED STATES COMMITTEES ON
APPROPRIATIONS AND INDIAN AFFAIRS FOR SUPPORT ON THE RECOMMENDATION FOR
INCREASES IN THE INDIAN HEALTH SERVICE HEALTH CARE FACILITIES CONSTRUCTION
PROPOSED IN PRESIDENT TRUMP'S FY 2018 BUDGET**

WHEREAS:

1. Pursuant to 26 N.N.C. Section 3, and 11 N.N.C. Section 10, the Coppermine Chapter is duly recognized and certified chapter of the Navajo Nation Government; and
2. Pursuant to 26 N.N.C., Chapter 1: Navajo Nation Chapters, Section 1 (B) (1) & (2), the Navajo Nation Council delegated to Chapter governmental authority with respect to local matters consistent with Navajo Law, including custom and traditions, and allows chapter to make decisions to govern with responsibility and accountability to community membership; and
3. Coppermine Chapter recognizes the Priority List of the National Indian Health Service (I.H.S) Health Care Facilities Construction by the method in which health facilities are built across Indian Country; the proposed Bodaway/Gap Health Center was noted as a priority for a new health facility in 2008 therefore placed on the National Health Care Facilities Construction priority list in 2008; and
4. Many of these communities within the Bodaway/Gap Service Area were grossly affected by the enactment of the Bennet Freeze; this ban sanctioned by the U.S. Federal Government prohibited any type of development such as constructing new homes, water lines, roads, even roof repair on homes were not allowed subsequently these isolated communities suffered due to lack of economic development, social services, appropriate health care services, and a decent education system; and
5. Although, the Bennet Freeze was lifted in 2009, the people in the area continue to suffer from lack of electricity, decent houses and lack of potable running water that impacts proper development for young people, communicable diseases, heart disease and cancer, and diabetes; and
6. President Trump's proposed FY 2018 budget list three I.H.S. health facilities for funding, however there is \$5.0 million cut in the line item which is clearly not adequate to bring these facilities to fruition; and
7. Coppermine Chapter is entrusted to protect the welfare and safety of its community members; currently a health facility does not exist within the Bodaway/Gap Service Area, the need is great, residents travel long distances to obtain health care, education social service, etc.; and

8. A new health care facility will improve access to care, behavioral health, and preventive services that are necessary to maintain and improve the health status and quality of life.

NOW THEREFORE BE IT RESOLVED THAT:



The Coppermine Chapter hereby approves the request of the 115th Congress of the United States Committees on Appropriations and Indian Affairs for support of the recommendation for increases in the Indian Health Service Health Care Facilities Construction line item proposed in President Trump's FY 2018 budget.
2. Furthermore, it be resolved, the increases will expedite the construction of the three listed in the proposed FY 2018 budget allowing for other health facilities on the national priority list to be funded and completed.


