

RESOLUTION OF THE COPPERMINE CHAPTER

SUPPORTING THE ISSUANCE OF A TRIBAL ACCESS AUTHORIZATION AGREEMENT (TAA),
FROM THE NAVAJO NATION TO THE NAVAJO TRIBAL UTILITY AUTHORITY TO ATTACH,
OPERATE, AND MAINTAIN AN EXISTING DISTRIBUTION LINE WITH FIBER OPTIC CABLE
WITHIN THE COPPERMINE CHAPTER TO DOROTHY TRUJILLO.

WHEREAS:

1. Pursuant to 26 N.N.C. §§ 3(A), the Coppermine Chapter is a certified Chapter of the Navajo Nation Government as listed at 11 N.N.C. §§ 10, as amended, which has also been certified pursuant to the Navajo Nation Local Governance Act, 26 N.N.C. §§ 1 et seq., as amended, and possesses the authority and responsibility to promote local projects that benefit the local community and its economic development; and
2. Pursuant to 26 N.N.C. §§ 1 (B), the Coppermine Chapter is vested with authority to review all matters affecting the community and make appropriate recommendations to the Navajo Nation, Federal, State and Local Agencies for appropriate actions, and is also empowered by the Navajo Nation Council to review all matters affecting the local community and to make favorable decisions in the best interest of all the community to protect and promote the general health, safety and welfare of the chapter's membership; and
3. NTUA is requesting support for a Tribal Access Authorization to obtain a right of way to construct, operate and maintain a new distribution line, with a fiber optic cable to serve Dorothy Trujillo, Coppermine, AZ, attached hereto as Exhibit "A"; and
4. Coppermine Chapter acknowledges this undertaking will benefit the residents and the community with much needed electric services and supports this endeavor.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Coppermine Chapter hereby supports the Navajo Nation's issuance of a Tribal Access Authorization (TAA) to the Navajo Tribal Utility to construct, operate, and maintain a new distribution line with fiber optic cable for Dorothy Trujillo, NTUA Project No. 14-223-0075.




