#### C. Porcupine Mesa Water Line Electrical – Frank Spencer. Floyd - The waterline project is suppose to provide water to 59 homes. Some homes are lacking water heater hookup, plumbing, etc. Residents have ask for assistance to the chapter to get hook up to the waterline.

Frank – Floyd gave me checklist to checks on homes. Some homes were lacking: water heater hookup, GFI, etc. Cost estimate is \$246.44 to purchase supplies for the homes and I am not going to request money for my services. Purchase supplies from Home Depot.

Floyd – need to approve to use chapter funds to purchase supplies for homes.

Chris – Frank has knowledge as electrician and have spent travel funds to go to the homes. Certified electrician make \$50 hourly so requesting for additional \$250 for his time and travel expenses.

Mae Slim – what about request for my mom for the water heater. No wire to breaker to water heater.

Floyd – get cost estimate for Zonnie Gamble and add to the cost estimate of \$246.44 plus your fee of \$250.

### VII. New Business:

#### A. CLUP Update & Schedule – NOT PRESENT

Top priority road project is Spur Road, N21 (BIA, Coconino, NDOT – provide assistance with funds for maintenance of road). I went to Flagstaff and said thank you to Board of Supervisors for the continue assistance with maintenance of Road N21. The cinder was transported from Flagstaff.

#### B. NTUA Powerline Extension – Laura Clark. Floyd – Laura has requested for powerline assistance with her home and she will explain her situation. Laura Clark is one of the names in the Powerline Project Phase 4. NTUA provided cost estimate for the Powerline \$538,000 and within the cost estimate Laura Clark project cost is \$14749. Laura went to NTUA herself and received cost estimate for powerline extension and was quotes \$6660.61 so Coppermine Chapter would be saving over \$8000 and the

distance is short. She had filled out the Financial Assistance. During the Planning Meeting, she indicated that she can pay a portion of \$6660 plus her child is disable. She indicated she can pay 25% and chapter pay 75%. So the chapter fee is \$4995.46. She had submitted documents: cost estimate, homesite lease, doctor statement, map, financial assistance application, etc.

Laura Clark – introduced herself. Rose White is my mom. Request for assistance with my electrical extension. My home is located near First Windmill, have built our own home, my child has Autism, moved to Tuba City due to education for my child and needs continuous care for my child. The Powerline Project Phase 4 will take 2-3 years but I need assistance due to my child.

Chris – powerline with fund assistance from SRP-NGS for highway to the Yellowmans. I live near Joe Yellowman. Need to request funds from SRP-NGS so that Joe Littleman and I can get powerline too.

Floyd – LeChee had requested \$5million for powerline project during the Contract Renewal. Now today NGS pays \$42 million to the Navajo Nation which they use to pay less. So in good faith NGS paid \$5million for LeChee powerline project. Other chapters wanted financial assistance too but was told NGS gave the funds to Navajo Nation.

Lola – its true what you spoke. Met with SRP for Re-Negotiation Meeting and said you have taking advantage of the Navajo Nation for many years. Coppermine had completed the powerline project which LeChee tap from the Coppermine Powerline to finish LeChee Powerline Project.

Margorie Begay – I use to work with Autism child and its true what she stated that its a lot of work for care of Autism child. The community needs to approve this financial request for powerline project.

Louise Begay – since you don't want a farewell dinner then put the money into this powerline extension.

Melvin Slim – her child has Autism then chapter should cover the total cost \$6660.61.

Edith Cling – agree with chapter paying the total cost of \$6660.61.

Change Resolution for Chapter to pay the full amount of \$6660.61.

C. NDOT Grading Agreement N6210, N6226, N201 – Margorie Begay. Floyd – this is requested to chapter every year.

Margorie Begay – Grading is for the bus route, senior center, senior meal transport, etc. Road N6226 is . The chapter use to work with Jason Yazzie. Some roads were not been graded. Some roads were maintenance by other like Coconino County and BIA. Road N6210 (13 miles), Road N6226 (1.7 miles), Road 6201 (0.3 miles) will be apart of the Agreement. Flat grading. Navajo Nation Sales Tax can use these funds for Clearances for roads which would speed up the process for Road Pavement Projects.

Floyd – Trading Post road Highway which is 6210, N20 to N6210 is graded for total of 13 miles and N6226 has 1.7miles then each chapter are given 15 miles for grading so Coppermine was lacking 0.3 miles. Road N21 is been maintained by Coconino County due to bus route. The grading isn't done offened for 6210 so now NDOT is going to be grading. Road N6226 is going to have Bionic Soil Pavement this coming summer which had already been approved by the chapter. Have completed inventory and 5 miles will be given Road #.

Mae Slim – storm comes through for Road N20 so wondering if NDOT plow the road?

Margorie – there are schedule blading. Now the County blade it. For NDOT, for emergency like wash out, like what Floyd had mention for Road Inventory not during Chapter meeting.

Floyd – for Road N20 its an emergency road which BIA estimated \$60 million but due to emergency it costed \$35 million. So during the storm there were washout on the roads, more vehicles and semi using the roads, during snow storm a lot of people went off the road, grading for snow storm starts with Navajo Mountain and Tonalea so should start with Coppermine due to high number of vehicles. Need to have turnout or maintenance of turnouts plus a need for more bus turnout. Need fencing for livestock for Road N20. Weigh limit on big trucks semi. Hazardous left behind from vehicles. Who maintains the Road N20? Coconino County stated they built the road and maintenance is who? BIA doesn't maintain road due to no documents and funding. Speed limit there is no enforcement. That is our road situation. Fence and gate repair.

Floyd – thinking down the road this N20 will become Freeway to link to Utah.

Lola – Thank you to Floyd for his years. Thank the community for attendance and food. Thank Margorie for coming to Chapter Meeting. I attended meeting in LeChee for the Bodaway Gap Clinic and crossing our fingers that Government still allocated funds for Facilities. Also Budget and Finance Committee had meeting also at Lechee. Also Resource Committee Meeting at Bodaway/Gap tomorrow at 10am. Appreciation Dinner for Floyd on February 4 (Saturday) at noon and if bringing dinner please let me know. Thank you for helping Laura and for bring food.

Valerie – thank Floyd for your 8 years. Thank the community for attendance, participation, and food.

Floyd – thank the officials Lola and Valerie for the years of working with and it's a team effort. Valerie had received chapter scholarship and in return wanted to help the chapter. Valerie takes care of the financial. Thank the leadership. Thank Lola for her leadership for assisting me on varies area.

D. Health Representative – Millie Brockle – NOT PRESENT.

Louse Begay – say word which was told to speak for the Road N20 and was nervous. Went to the meeting to speak for Road N20 and had seen Floyd and Lola then I felt better is when I realize that the chapter officials were for the community. I am proud to say I am from Coppermine Chapter. I hear from others that Coppermine have good chapter officials.

E. Special Diabetes – Edbert Little. I work in Tuba City and have staff of one me and other staff have retired. Introduced himself. I talk about Diabetes to the people. Just to inform the community about our body and need to take care of our body and given only one body. Need to take care of our body with food intake. If we go over and less then our body will not work well. Need to eat right food, exercise, etc. Need to take care of our blood and if you intake a lot of fat which will affect our blood. If you don't take care of yourself like eating too much which effects your health. Too much sugar in the body. Need to eat more vegetables and exercise. Its up to the individual and are given only one body to take care of our body.

Melvin – what about calories will that effect you? Need to look at Calories and Carbohydrate are the two to look at?

Edbert – yes

Melvin – have seen Nutritionist and was told to watch the calories and Carbohydrate and can get out of Diabetes.

Edbert – Type 2 Diabetes and baby born with Gestational Diabetes can get out of Diabetes. Also Pre-Diabetes is for heavy people which you notice that. Need to limit food intake.

Alice – question meat, I am not red meat eater but I love mutton and fat. So I eat fish or chicken. Because I have condition.

Edbert – if you eat more vegetables and fruits is good if you want to improve your body. Limit meat because of fat. Protein from meat which effects your bones. Protein from Green Vegetables is better for your body. Meat protein when you pee you are peeing your calcium. There is a lot of Iron and Zinc in Meat. Its starts to affect your brain. 10% meat should be apart of your diet or no meat. Cow milk is meat, 2 eggs which is meat, 2 sausage which is meat, so there is no vegetable or fruits. Same goes for lunch so just eating a lot of meat. Need to take care of ourselves. Need to limit sugar like sodas. Meat makes you grow faster so you would hear girls go into menstrual.

Comment: like Flagstaff did away with Junk food.

Edbert – I get requests from schools. Need to educate the children to eat right. Some people eat fried potato with meat then bread which is what majority of people eat. In the past before white man came us Navajos lived more healthy life because we harvest our own food, hunt our food which is exercise, get water which is exercise, etc. Meat use to be expensive in the past then now decrease in price so all can eat meat. They did this for cow meat, pop, chips, etc. Even if you eat meat but need to exercise after you eat. The first 15 minutes is where the fat is in your blood then next 15 minutes is where the fat in the organs. So 30 minutes is where it starts to eat the fat in areas of body.

Comment: I don't believe the hauntivirus because in the past when I was younger the mices would run on us while we sleep.

Edbert: yes I agree with you.

### RESOLUTION OF THE COPPERMINE CHAPTER

**RECOMMENDING TO RESOURCES AND DEVELOPMENT COMMITTEE OF THE NAVAJO NATION COUNCIL TO APPROVE THE NAVAJO DIVISION OF TRANSPORTATION'S PLANNING EFFORT TO DEVELOP THE NAVAJO NATION'S FY 2017 ROAD MAINTENANCE AND ROAD IMPROVEMENT PLAN FOR COPPERMINE CHAPTER AND HAVE PRIORTIZED N6210, N6226 AND N201 AS LISTED UNDER THE FEDERAL HIGHWAY TRIBAL TRANSPORTATION PLAN AND THE NAVAJO TRIBAL TRANSPORTATION PLANNING PROGRAM.**

**WHEREAS:**

1. The Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation government, pursuant to 26 NNC Section 3 11 N.N.C, Part 1, Section 10; and
2. Pursuant to the Title 26, NNC, Section 1 (B), The Coppermine Chapter is vested the governmental authority to review all matters affecting the community and to make appropriate correction when necessary and make recommendation to the Navajo Nation and other local agencies for appropriate actions; and
3. The Navajo Division of Transportation, under the guidelines and planning program of the Federal Highway Tribal Transportation Program and the Navajo Tribal Transportation Planning Program, supports the effort towards improving and upgrading all primary roads to area schools and chapter government facilities and addresses the public transportation safety concerns to conduct business to maintain a quality of life; and
4. The cooperative agreement between Coconino County, The Bureau of Indian Affairs and the Navajo Nation, in joint partnership exercise their powers for road maintenance and road improvement services on system roads located within Coppermine Chapter; and
5. The Navajo Division of Transportation agreed to assist the transportation partners in revising the Agreement between Coconino County and BIA by adding the N6210, 13.0 miles, N6226 1.7 miles and N201 0.3 miles to the Navajo DOT Regional Road Maintenance Program;
6. The Coppermine Chapter recognizes the severity for road improvement and maintenance in the community, has selected and prioritized the road maintenance and improvement plan for the following school bus routes.
  - a. N6210 13.0 miles
  - b. N6226 1.7 miles
  - c. N201 0.3 miles

NOW THEREFORE BE IT RESOLVED THAT:

1. The Coppermine Chapter hereby recommends to the Resources and Development Committee of the Navajo Nation Council to approve the planning efforts of the Navajo Division of Transportation to develop and implement the Navajo Nation's Priority Road Maintenance and Road Improvement Program under the guidelines of the Federal Highway Tribal Transportation Plan and the Navajo Tribal Transportation Planning Program.
2. Furthermore, The Coppermine Chapter request The Navajo Division of Transportation, under the guidelines of the Federal Highway Tribal Transportation Plan and the Navajo Tribal Transportation Planning Program, to prioritize a road improvement plan and secure funding for N6210 13.0, N6226 1.7 miles and N201 0.3 miles as road priority projects.

#### WHEREAS:

1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C. Section 10 the Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
2.
