APPROVING AND SUPPORTING THE KAIBETO BOARDING SCHOOL GOVERNNING BOARD OF EDUCATION TO ADOPT AND TRANSITION FROM BUREAU OF INDIAN EDUCATION OPERATED SCHOOL TO A FEDARALLY FUNDED NAVAJO GRANT SCHOOL.

## WHEREAS:

- 1. The Coppermine Chapter is a duly recognized and certified Chapter of the Navajo Nation Government, pursuant to 26 NNC Section 3 and 11 NNC, Part 1 Section 10; and
- 2. The Coppermine Chapter is vested with the Governmental authority to review all matters affecting the community and residents and make appropriate recommendations to the Navajo Nation and other local agencies for appropriate actions, pursuant to Title 26 NNC Section 1 (B); and
- 3. The Coppermine Chapter is Pursuant to Public Law 107-110, Part B-Bureau of Indian Affairs Program, SEC. 1120 Declaration of Policy, includes the "policy of the United States to fulfill the Federal Governments unique and continuing trust relationship with and responsibility to the Indian people for the education Indian children and for the operation and financial support of the Bureau of Indian Affairs-funded school system to work in full cooperation with tribes toward the goal of ensuring that the programs of the BIA-funded school system are of the highest quality and provide for the basic elementary and secondary educational needs of Indian children, including meeting the unique educational and cultural needs of those children"; and
- 4. The Coppermine Chapter is Pursuant to Navajo Nation Code, Title 10, Education, Subchapter 1, &210, states the "Chapter of Navajo Nation are authorized to established local Navajo Community School Boards," who "shall have the governance of schools funded and operated by Bureau of Indian Affairs for the Education of Navajo students"; and that it reaffirms the established intent of the Navajo Nation Council Resolution CAU-87-69 wherein states "the Navajo Nation Council authorized the establishment of the local community school boards as a means of improving the quality of Navajo Education and of encouraging greater participation by community people"; and

- 5. The Coppermine Chapter is trusted with the responsibility for the betterment and advancement of its community members; and
- 6. The Coppermine Chapter recognizes the importance of advancing child development and improving the quality of education for its local and surrounding communities, 10 N.N.C. 200 C.

## NOW, THEREFORE, IT BE RESOLVED THAT:

- 1. The Coppermine Chapter hereby supports and approves the Kaibeto Boarding School Governing Board of Education to adopt and transition from a Bureau of Indian Education operated school to a federally-funded Navajo grant school; and

- 3. The Coppermine Chapter hereby supports and approves the Kaibeto Boarding School Governing Board of Education to improve the quality of education for K-8 grades based on the annual results of the low national and state-administered tests scores obtained from the school, 10 N.N.C. 200 B; and
- 4. The Coppermine Chapter hereby supports and approves the Kaibeto Boarding School Governing Board of Education to improve the quality of education by ensuring educators are Arizona State certified and credentialed accordingly, 25 CFR, 38.5; and
- 5. The Coppermine Chapter hereby supports and approves the Kaibeto Boarding School Governing Board to monitor and make recommendations on personal and employment practices, financial planning, and participate in other oversight responsibilities.
