WHEREAS:

2. Pursuant to 26 N.N.C., Section 1 (B), Coppermine Chapter is vested with the authority to review all matters affecting the community and to make recommendation to the Navajo Nation and other local agencies for appropriate actions, and
3. The Fiscal Year 2025 “General Fund, Special Revenue Fund – Internal” Funds will be used for chapter operation and activities to benefit community membership; and
4. The Coppermine Chapter approves the budgets (“General Fund, Special Revenue Fund – Internal”) in the best interest of the Community. Listed below:
