RESOLUTION OF THE COPPERMINE CHAPTER

COPPERMINE CHAPTER APPROVES A STUDY BY NORTHERN ARIZONA UNIVERSITY STUDENTS TO INVESTIGATE ENVIRONMENTAL EXPOSURES RELATED TO ABANDONED MINE TOXICANTS WITHIN COPPERMINE CHAPTER AREA.

WHEREAS:

- 1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C., Section 10 the Coppermine Chapter is a dually recognized and certified chapter of the Navajo Nation Government; and
- 2. Pursuant to the Title 26, N.N.C., Section 1 (B), The Coppermine Chapter is vested with the governmental authority to review all matters affecting the community and to make appropriate correction when necessary and make recommendation to the Navajo Nation and other local agencies for appropriate actions; and
- 3. Pursuant to the Title 26, N.N.C., Chapter 1, Navajo Nation Chapter, Section 1, Amendment (B) (1) (2), the Navajo Nation Council delegated to Chapter governmental authority with respect to local matters to make decisions to govern with respect to local matters to make decisions to govern with responsibility and accountability to the community membership; and
- 4. Many abandoned uranium mines and mills are present on the Navajo Nation, in addition many of the local wells that are contaminated by uranium arsenic, and other toxicants.
- 5. Many community members are concerned about the exposure of abandoned mine toxicants through water, soil, plants used for food and medicine grown near the abandoned mines and dust.
- 6. To develop the best policy on cancer incidence linked to environmental exposures; this information along with the Navajo Fundamental Laws will be used to shape policy in collaboration with community and tribal officials of the Navajo Nation.
- 7. The study will consist of environmental sampling such as collecting water, soil, plants, livestock, and dust samples, in the areas surrounding the community members to participate in a survey on environmental health and potentially provide urine samples for the uranium analysis. This request is part of a larger study investigating the connection between cancer incidence and Nation Students from Northern Arizona University will be involved with all aspects of the project. After we have collected the results of the project, we will report back to the Coppermine Community. This test is carried out with the CLUPC (Chapter Land Use Planning Committee) to collect information that will benefit the community.

NOW, THEREFORE BE IT RESOLVED THAT:

1. Coppermine Chapter supports Northern Arizona University in the research of the investigation of the link between cancer incidence and environmental exposure for the community of Coppermine Chapter.
