My name is Adrian Dodson, we are with ETD Inc. out of Flagstaff, Arizona. We are consultants with Public Relation and Environmental, we are representing a company called Chanana Copper out Denver, Colorado. They were here either June or July 2025, do a presentation and get a resolution for the reconnaissance work to evaluate for any copper deposits because they are interested in developing a copper project here at the Chapter. We just wanted to come in to get on the agenda and let you know the status of the project and what we are planning to do in the next few months.

V. Presenters:

- A. Shannon Reid -Chapter Scholarship;
 - 1. She introduced herself in Navajo, is a full time student attending University of Arizona in Tucson, Arizona, majoring in Law and thank you for the scholarship, that will help me pay for my school.
- B. JoAnn Pioche -Sponsoring LeChee Clinic Resolution;
 - 1. She introduced herself in Navajo, she has provided a copy of LeChee Chapter resolution for LeChee Clinic to stay open, we want to change it to "same day clinic."
 - 2. We have families and relatives who live in Page area and people get seen after work or lunch time. I am asking for supporting resolution because we want to keep the LeChee Clinic open, pass the Echo Cliff opening. At time as we know across the reservation, when a new clinic opens and other clinic will sit vacant, because of lack of staff. We want to keep it open but it's up to Tuba City Hospital and thank you.

- E. Roberta Lyons -Hello Heart;
 - 1. She introduced herself, original from the Tso family of LeChee. I'm here today to share an ongoing study years ago to our community on liver scans. It's free to our community members and we are paid for participation. It is NAU and Arizona of University that came to our community, they asked a couple of Chapter Houses "can we do a study in your community" a lot of them said no, but we said yes. It's not just for LeChee, it's for Western Agency.
 - 2. So, we are actually picking up this year and we are going to start in February, we haven't picked a date but will be the week of 21st when Northern Arizona University and University of Arizona will be coming out to do liver scan, usually four (4) to five (5) hundred dollar per scan. People have misconception that alcohol damages liver and have liver cirrhosis, that is not true. Unfortunately, it is our diet, there is a lot of things that implement and discreet the stuff that is in your liver.
For example; three years ago, I was scanned and had 260 level, I was at a low level but at stage 1, in two years I quit drinking, cut down on my fry bread and recently I went to Tucson University of Az, learn to scan people. I got approved to scan people, we are the

only Chapter approve to run the scan and it a research study, can only be done in LeChee.

3. We went around our community and what do you want us to do. We created a walking group in September, we started with 3 and now at 30 participants, we do it every Tuesday and Thursday. We are trying to start a Walking Group here in Coppermine, I'm then happy to provide water and snacks, we want to create a healthy life style for the community. That's why I'm trying to bring Heath Awareness program, it's been ongoing for couple of years and they want to come back. Will start in February, March & April this year, we have 120 scans to complete the research, so we are looking for participants, has to be over 18 years of age and want anyone who wants to participate. I can scan whatever you want, tell you how you're doing and wasn't expecting this many people. I apologize, I will bring some flyers, hand-outs and if you want to talk to me, will give you information. I do have a social media Facebook page where I post information. We are doing Lego night at LeChee Chapter from 1:00 pm on Friday, that will also be on chapter website.

F. Adrian Dotson -Introduced himself in Navajo, lives in Flagstaff and with EDT Incorporated. Eunice Tso -Introduced herself in Navajo from LeChee, and lives in Flagstaff. Lee Jack Sr. -Introduced himself in Navajo from Dilcon area, I help them with their presentation.

1. Adrian Dotson -Like I said, we are working with EDT Incorporated out of Flagstaff and we are actually here representing Chakana Copper out of Golden, Colorado. Back in September 2025, Chakana obtained a Geological Reconnaissance Permit from Mineral Department of the Navajo Nation, that permit allows them to evaluate the copper here at Coppermine Chapter. Over the next few weeks, we will try to work with some of Grazing Permittees to go onto their land to do reconnaissance. What that means is just 1. Walking the land, 2. Collect surface (rock) samples, 3. Take photos, and 4. Creating maps. That does not allow them to do digging, drilling, construction, or trespass without permission. We wanted to get on the agenda for Regular Meeting, we will provide hand-outs at the next meeting, and we weren't expecting to do a presentation this time. We will more information and a thorough presentation.
2. Lee Jack Sr. -Explained Adrian's presentation in Navajo, will do reconnaissance within 30 square mile and will take a while to start because they have to do the study first.
3. Eunice Tso -We will give you more information, exactly where this is and we going to try get any questions from you. Just be transparent with everything and that's we promise to you, with public relation, public engagement, get any information that you want or you need so you can make a decision at the end of the day.
4. Lee Jack Sr.-We also talk about water, they are not going to dump water just anywhere, it will be recycled and they say it's going to be pretty much environmental clean.
5. Hailie Joe -Are you asking us or are you telling us to do the observation? Our people do not want mining.
6. Adrian Dotson -We are basically saying we have the permit from the Navajo Nation so we can have access to the land and do the reconnaissance for now. **35:01**

7. Eunice Tso -We understand, I feel like though I guess at the last meeting in September, when there was a vote, they reviewed the meeting minutes, we reviewed the minutes and there were a lot of misinformation. So, we want another opportunity to come back and talk about those things so that information is correct out there.

*There were questions, concerns, and discussion from the community. Some elders remember what happen when the first company came in to dig up copper, some drillings are still open and no clean up.
