I am asking leadership for the signatures to give us signature and its the last one we have. Its one hurdle after another. We are going through the Navajo nation process. We need the signature and to complete the process. Church is good for the community.

Lola – has this gone through clup

Jessie – yes have gone through clup, we had signature on difference form and land department said they have changed their form and need to get signatures again, we were working with land committee and she resigned.

Lola – this will go through window rock and they want a language to be state Jessie – yes we have the language, came to halt during pandemic,

Lola – we are getting mike halona to come to Coppermine for presentation,

Allen – you have the surveys

Jessie – yes it was submitted

Allen – linda have you seen the surveys

Linda – Stanford should have the papers, need to have the gps points,

Linda – they need management plan, jessie (its in there as well), they had old forms Stanford – package is like homesite lease, survey, biological clearances, resolution, resolution is back in 2018 so need current one to reaffirm, consent form is back then but still valid, consent form is for the residents living in that area like Annie Yellowman, Rosita Curley, Al Lane, etc. grazing permit holders only.
