- 2. TCRHCC Lela McCabe Ecology cancer has decreased since doctors have retired so we are lacking positions in our Ecology. We are sending patients to Flagstaff or Phoenix. We have assistance program, Navajo hopi foundation, funds for cancer, you need to go see Rigg at Ecology office. Board President and other went to Washington DC. We had 2 urgent meeting on long care facility. This coming Friday meeting with Buu at the board room. June 17 meeting with Navajo. We are providing training. Train and hire and staff for medical coding, information technology, pharmacy, etc. I want language department to do presentation. Linda TCRHCC is taking big load for south Coppermine, they want to staff it with professional at clinic, from lela report which have problem in staffing, lechee clinic are under staff and they can't help us so we end up going to tuba city, if clinic is in our area then it should be fully staffed.

Lela - We need to know this for our monthly meeting.

Linda – what about IHS on their training for nursing, they were required to come back to IHS to work for work experience,

Lela – cant hear.....

Valerie – person with bachelor degree had applied for almost 2 years couldn't get hire. It seems like its who you know if how you get hired. We talk about hiring our children after they graduate but that is wrong.

Lela – we person heading the hiring and we review applications too

1. Council Delegate – Helena Nez Begay – attended dine school board association, they had summer conference, had a lot of school board members, many presenters that they provide for the school, department of dine education was present. Had meetings at twin arrows which first meeting was regarding background check which applicant can start working which background check is going through, meet with social services and burial assistance can go off the reservation of \$2500 of natural cause and \$3500 for covid related, CIB is needed for new born to apply for hardship assistance, down the application online and submit online and attach CIB and can be given to Helena for submittal as well. Meeting on the railroad. Tomorrow is delegate meeting on road. Navajo Prep is one going have ground breaking for new residential hall. Working on setting up meeting on 26 or 27 regarding western pipeline.

Stanford – are on education committee

Helena – im on HESA

Stanford - a lot of headstart are closed,

Helena – they don't have many headstart on Navajo nation, still working on it

Stanford – listening eduation with Navajo nation and where should we put Navajo language, should we put it in the freshman year, etc...it should be at headstart

Stanford – you know economic development meeting tomorrow

Helena – yes at lechee chapter and its at the tail end of the Roads Meeting

Linda – we have elected you for district 1 to advocate for us, you need get funding for your chapters, I hear you at the council and you are not advocating for our chapter

Paul – richfeild dormitory had plans, continue the plans in getting new buildings for schools,

Helena – tonalea elementary will start, kaibeto was completed, tonalea is in the design phase, in stanley case they wanted to meet with president so he working with Sarah to get meeting, I am looking for funds, I am not going to report until its reality,

Paul – I don't think what I said was mean but a talking discussion, we address each other with Ke' and don't use names but use Ke'.

Stanford – I tell my grazing officials and at the meeting to use Ke' and its teachings. There are strong words but need to be strong minded.

- Chapter President Allen Fowler Jr. provided update on ARPA meeting at twin arrows, there is procedures for the ARPA chapter projects, driving over and saw pothole at milepost 6 which will be discussed at tomorrow's meeting with NDOT to keep semi-truck off the road N20, as driving to twin arrows I had activity at the clinic site and they were doing soil testing,
- Chapter Vice-President Lola Smith upcoming meeting with mike halona having to do with general land leasing for south portion of Coppermine, we need for economic development, native promise receive grant for economic development so need to identify land for this development,
  - Stanford I had suggesting for land leasing training to the 5 chapters, clup president need to be involved since they work
- 4. Chapter Grazing Official Stanford Fowler report on windmills, water tanks, cattle guards, suggest to install gates, very sandy at 2<sup>nd</sup> windmill, saw colt in water trough at 2<sup>nd</sup> windmill, doing branding, call me for your tally and branding, if you got horses in the corral and want it hauled off then contact chapter administration, olin begay handles picking up horses, water is going down so you'll see more animals around your house, dispute causes water resources to not work on some windmills, vaccination from grazing is not given, if you purchase vaccination has to be prescribed, can't purchase vaccination from the store, to save hide so branding on leg to get more price for your cow, finished hours for inspector, doing homesite lease, arch clearance is expensive \$550, survey cost \$950 from window rock, goldtooth for survey
- 5. CLUPC President Linda Long spoke with ASU yesterday, we discussed some update on clup manual, claraification on several items, he is getting ready for pubic hearing, Floyd stevens is our clup consultant, hopefully we will be hearing soon. Welcome lavern Tsosie and jessie billy to clup committee. I hope you bring good ideas and advice.
