RESOLUTION OF THE COPPERMINE CHAPTER OF THE NAVAJO NATION

REAFFIRMING RESOLUTION NO. CO-07-034-17 THE APPROVAL AND SUPPORT OF THE BUREAU OF INDIAN AFFAIRS (BIA) ROADS WESTERN NAVAJO AGENCY AND THE NAVAJO DIVISION OF TRANSPORTATION'S PLANNING EFFORT TO DEVELOP THE NAVAJO NATION'S FY 2023 ROAD MAINTENANCE AND ROAD IMPROVEMENT PLAN FOR COPPERMINE CHAPTER AND HAVE PRIORITIZED NR21-2 (COPPERMINE TO KAIBETO ROAD) AS LISTED UNDER THE FEDERAL HIGHWAY TRIBAL TRANSPORTATION PLAN AND THE NAVAJO TRIBAL TRANSPORTATION LONGRANGE PLANNING PROGRAM TO BE AMENDED AND IN SUPPORT OF PAVEMENT FOR NR21-2 (COPPERMINE TO KAIBETO ROAD) FOR BUS ROUTES FOR FIVE (5) SCHOOLS AND LOCAL TRAFFIC AND EMERGENCY SERVICES.

WHEREAS:

- 1. The Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation government, pursuant to 26 NNC Section 3, 11 N.N.C., Part 1, Section 10; and
- 2. Pursuant to the Title 26, N.N.C., Section 1 (B), The Coppermine Chapter is vested the governmental authority to review all matters affecting the community and to make appropriate corrections when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate actions; and
- 3. The Navajo Division of Transportation, under the guidelines and planning program of the Federal Highway Tribal Transportation Program and the Navajo Nation Transportation Planning Program, supports the effort towards improving and upgrading all primary roads within the Coppermine Chapter and addresses the public transportation safety concerns to conduct business to maintain a quality of life; and
- 4. The cooperative agreement between Coconino County, The Bureau of Indian Affairs, Navajo Department of Transportation and the Navajo Nation, in joint partnership exercise their power for road maintenance and road improvement service on system roads located within Coppermine Chapter; and
- 5. The Division of Transportation agreed to assist the transportation partners in revising the Agreement between Coconino County and BIA by adding the NR21-2 (Coppermine to Kaibeto Road) the Navajo DOT Regional Road Maintenance Program and in support of Long-range Plan for Pavement of NR21-2 (Coppermine to Kaibeto Road) for lite traffic; and
- 6. The Coppermine Chapter recognized the severity for road improvement, maintenance and pavement in the community, has selected and prioritized the road maintenance and improvement plan for school bus routes.

NOW THEREFORE BE IT RESOLVED THAT

- 1. The Coppermine Chapter hereby recommends the Bureau of Indian Affairs (BIA) Roads Western Navajo Agency, Navajo Division of Transportation to approve the Planning efforts for Road Maintenance, Road Improvement and Pavement of NR21-2 (Coppermine to Kaibeto Road) under the guidelines of the Federal Highway Tribal Transportation Plan and the Navajo Tribal Transportation Long-range Planning Program.
- 2. Furthermore, The Coppermine Chapter request the Navajo Division of Transportation and the Bureau of Indian Affairs (BIA) Roads Western Navajo Agency under guidelines of Federal Highway Tribal Transportation Plan and the Navajo Tribal Transportation Long-range Planning Program for Road Maintenance, Road Improvement, and Pavement for bus routes and five (5) schools and local traffic on NR21-2 (Coppermine to Kaibeto Road) is a road priority project.
