At the time when the gaming was an urgent resolution was needed from it. Again, that was if there were budgeted funds available. But in this case, they mention the allocations should be for planning and regular meetings and then there's a certain another amount for agency meetings. So, we want to mention usually if there's carry over additional savings from maybe your vacant position that's the time, they utilize funds go towards special meetings if needed. But, in this case there was no funds available for a special meeting, therefore, we were asking chapters, if they could hold a meeting without being compensated on that, for that reason, so I would request that, that resolution be removed. Thank you.

President Fowler replies thank you again, Mr. Maloney. I never got that email and got the email to approve the funding of the asap and never got email about not getting paid for that.

ASC Milford Maloney replies I guess my question is there any special meeting funds available, or was it budgeted from the carry over amounts?

VP Lola Smith replies we'll have to Roylentia. Roylentia are you on? Roylentia are you on, our AMS? Did you get that question?

AMS Roylentia Begay replies what was that? Audio is not clear.

VP Lola Smith reply is unclear.

President Fowler replies I think, our AMS, Roylentia, do you have any carry over funds for that special meeting?

AMS Roylentia Begay replies no, there's not carry over funds, just what was allocated in 2021.

VP Lola Smith reply is unclear.

President Fowler replies Madam VP do you have a question?

VP Lola Smith replies Mr. Maloney we as chapter officials had agreed that we wouldn't be paid for agency meetings because there's only nine hundred in there, and that's not enough to cover agency meetings for us. So, that is the reason why we decided to look into transfer money from that account and we really never got word or a memo from various department about what you had just mentioned, that we can only utilize the budgeted account for special meetings.

ASC Milford Maloney replies thank you Madam VP, Chapter President, as for as with the allocations, chapters are allocated adequate funds to cover twelve meetings, twelve planning meetings, twelve regular meetings and four district and/or agency meetings, and this is for each of the three officials and partial, I know the full amount

of the stipend wasn't given out this past year, there's one quarter that their looking to funds for, so, right now your budgeted for the remaining meetings. So, that's according to your resolution it mentions that thousand is four two officials when your agency meetings are for three officials, so, your either taking funds away from third chapter member to serve purposes, just the two individual officials, there is agency meeting that will takin place this weekend so they would be able to get compensated for that. Again, that's just anytime that's why the budgets should be reviewed to make sure funds are available before any payments are made out from any funds. Because in the first place, there was no budgeted amount issued out for the special meeting, therefore, it shouldn't have been, because there's no funds available for that to have for a special meeting. I like to say thanks.

President Fowler asked Tyrone Whitehorse are you online?

Tyrone Whitehorse replies Yes, I'm here.

President Fowler replies I am part of a non-profit organization called Together on Turtle Island. We are a multi-tribal, non-profit serving all natives around the country. I personally am from this area: LeChee, Coppermine and Kaibeto area, that's where I'm from. So, I grew up there. One thing that we wanted to do, we've been helping a lot with COVID Relief over the past year, but now that COVID will be coming

to an end soon, we wanted to be able to try to help another way, and one of the ways that we want to help is by helping provide water for people on the reservation. One of the things that we have access to is we have access to what's called an Atmospheric Water Generator. What is does, it pulls water that's already in the air and condenses it into water so that people can use it. It's been tested all over the country. They use it right now in the South. Also, in Puerto Rico where it's being used a lot because people need water there. It's being tested as well down in Phoenix and the desert, so it works there in the desert. So, what we want to do is we propose we wanted to bring up a resolution to provide one of these water generators there on the Coppermine Chapter grounds as a pilot program to provide water for use for the chapter members, and see how well it goes and if it goes well, then we're going to expand this out to other areas of the reservation that need water. So, that's the proposal we have we proposed to, set up an atmospheric water generator there on chapter grounds this will not cost the chapter anything and it won't cost anybody anything that's my whole goal, is to make this accessible to my people there, for at no cost. So, that's what we propose, and I wanted to bring that up today to the chapter meeting with this resolution. Thank you.

President Fowler replies Thank you, Tyrone, I support this, and I think we need to learn how to get water different water resources, and especially people who don't have a water, that haul water for their cows, it's a good a pilot program that we can see that we can see if it works, like you said it's not going to cost the chapter anything. You have any questions? Grazing Official?

Grazing Official Stanley Fowler Hello, Mr. Tyrone Whitehorse, yes, for myself I support this resolution, and we would like to see how this whole works on the reservation over here. For the dry weather we want to see what we can get through the summer, see how much water we can get in days, and that way we can monitor and see if it will be beneficial to us. Yeah, I support it to. So, we can have it put on the chapter grounds and then you can see how it works. We'll see and other people on the reservation can come out and look at it, see how it works. We support it and I support it, the whole thing. Thank you.

President Fowler replies thank you, brother, Grazing Official. Okay, anyone have any questions? Madam VP make a motion.

Sherry Stevens replies Mr. President this is Sherry Stevens here, I have a question for Mr. Whitehorse. How many per gallon is it producing when it's set up or is it already being used somewhere else, around here too?

Tyrone Whitehorse replies it's not being used anywhere else on the reservation. It has the potential to be producing, I think 4,000 gallons a day, depending on what the weather is. I looked at it and I chartered everything out, it looks like the better time here in Coppermine is going to be around, starting in August all the wait till about May, that's when it will be producing the most. We can also set up barrels and stuff to store it, if needed, but it's like I said, it's still being tested in Phoenix, so, we don't know exactly what it's going to produce in the summertime when it's hot out. So, this would also help toward understanding how much it would produce on the reservation when it's warm outside. Sherry Stevens replies okay, that answers my question, I'm all for it then. I'm hauling water right now. Thank you.

President Fowler replies thank you again, Sherry for the question. Any more questions? Madam VP and Madam Secretary, do you have a motion? Delegate Begay. We got a motion from Madam VP to approve. Do I have a second Madam Secretary or Delegate Begay? Secretary/Treasurer Delores Dempsey replies, I second, this is Delores. President Fowler replies okay, Delores second. How do you vote Madam VP? a. Bodaway/Gap Health Clinic Updates – Glenna Manymules-Bitsuie President Fowler asked Glenna Manymules-Bitsuie are you online? If you're online press *6 to unmute yourself. Are you online, Jeremy?

Glenna Manymules-Bitsuie replies hello, I'm sorry, I apologize. I don't know how to work the system. I work as a Health Planner for Navajo Department of Health, Office of Planning and HealthCare Facility Development. I am going to give an update on the Bodaway/Gap Health Center Project. For those that don't have the updated information. In 1998 Indian Health Service decided to visit all the Indian tribes, their reservation to do a masterplan for HealthCare Facility, if their available, if they're not available under Tuba City Bodaway/Gap census area. The communities were Kaibeto, LeChee, Coppermine, Bodaway/Gap Chapter and San Juan Southern Paiute needed a HealthCare Facility in your area. In 2005-2006 there was a resolution to study Phase One Site Selection Report, this was a primary study. Coppermine chapter proposed three different areas and Bodaway/Gap offered one, and that is by Cedar Ridge. In 2007 Coppermine Chapter came up with a resolution and it recommended site four, which is north of Gap Primary School. So, in 2007 Coppermine did a land withdrawal for that area, 75 acres. In 2005 Bodaway/Gap proposed a resolution to withdraw land in Cedar Ridge, but there was no money. In 2008, the plan of operation was approved through the 21st Navajo Nation Council. Then, in 2012 Tuba City proposed to have their Board of Directors that represent the Chapters in the Bodaway/Gap service area, let them join the Steering Committee, and it was proposed to the Steering Committee at that time, they agreed. Although there was the resolution that was approved by the Navajo Nation for the Department of Health to fund a planning office for the Steering Committee, there was no money. Back in 2016 Kayenta opened, from there I focused on Bodaway/Gap. Today, I am still working with the Steering Committee and the Project from Indian Health Service, Navajo area. To date, going back to 2008, program justification document called PJD it was approved but it was a draft copy, it didn't have all the necessary, it had very limited health care services. There are four project on the Navajo Reservation: Gallup, NM, (Indian Medical Center), Pueblo, NM, Dilkon, and Bodaway/Gap, those four weren't on the Indian Service priority list, but, in 2008 they were Grandfather to the priority list. Once you get on the priority list, you are eligible for funding, although, there is a lot of project ahead of you. In 2018 we received our first appropriation from Congress. And this priority list is, the facilities are all funded, Federally Funded, Congress is the one that changes the priority list and they appropriate funds for the project. In 2008 when the PJD was approved and the POR (Program of Requirements) it identifies staffing for the facility, so, until the funding becomes available, then these documents will be updated, that's for the four projects. In between the Steering Committee has been lobbying Congress, they've been going to conferences, to see if there is any money so that we can speed up this project. In 2018, Congress appropriated the first phase of funding, 10 Million to help finish the phase one site selection and elevation report. Phase one, it identifies the land, there's land withdrawal we had to go back and revisit the two sites that were recommend by the two chapters. They still recommended site four, north of Gap Primary School. Phase one was approved in the latter part of 2019. In 2020, we were getting ready to get all these updates done and complete phase two site selection report, then the pandemic happened. The Planning office from Indian Health Service had to shut down because they were manning this COVID 19, they were reassigned to work at the Navajo Nation to do their services that needed to get done. Our project was idling in 2020. We moved back into our office in August. We were still having our Steering Committee meetings by teleconference. The Planning office took a while to complete the update, the PDJ and POR needed to be updated. In January 2021, the jumpstarted the project again so the consultant is working on finalizing phase two site selection and elevation report, which should be finished by June. Then we will be soliciting for a design team in the Fall. Also, one

thing that happened during this process was back in May 2020 meeting, Tuba City Corporation proposed that 638 program, they proposed to design and construct the Health Center. The Steering Committee approved the design and construction. Right now, we are waiting on Indian Health Service to complete the surveys. Phase two is more in depth, they study the soil, environmental assessment, archeological studies, that what they're going to do. Because of the update, I am going to introduce a resolution at the April Planning meeting because of the 75 acres, we need to increase it by 10 acres. Because of the update to the PDJ and POR it has increased in the footage of the new building because we added new programs. Then there will be 92 staff quarters. When the PDJ was approved in 2008, the staffing was 133, but because of the update and new programs, they are adding to project, there is going to be 230-240 staff, full-time employees at this health center. The other thing that they added to this project is a cafeteria because they understand it's too far, there is no services nearby, therefore, it increased the footage of the new facility. To date, this new facility is going to cost \$152,200,000. We have Steering Committee from all four chapters, and there was on from the Southern Paiute, she left and hasn't been replaced, we have Lyonel Tso from LeChee, and we have two from Coppermine, Lola Smith, she's president of the steering committee and Leila McCabe, she's a member of your chapter, she's the vice president, then we have Dolly Lane, she's from Bodaway/Gap, she's the secretary for the committee, and there's Kimberly Williams from Kaibeto. We only have five representatives right now. Bodaway/Gap had two,

we lost Thomas Tso and he'll be replaced once we get going with this project. Are there any questions? President Fowler replies thank you again for your report. Thank you for working for us and getting a clinic near the chapter house. Are there any questions, Madam VP, Madam Secretary, Delegate Begay or from the community?

LDA - Jerry Williams replies Mr. President?

President Fowler replies go head, who's this?

LDS – Jerry Williams replies Jerry Williams, Delegate Begay's LDA. Hello, President, Madam VP, Madam Secretary/Treasurer, Delegate Begay. I was trying to keep up with your report. I am trying to figure out the location, towards Bodaway/Gap. Is this going to be under Bodaway/Gap or Coppermine Chapters? You mentioned, Gallup HIS medical center, I'm curious, here in Page there a building called Encompass, it used to have medical, it closed. There's one nurse and they opened the pharmacy. There's a lot of people that come in from Kaibeto, Inscription House, and Shonto looking for medical care. The local clinics don't take IHS. I am thinking maybe there could be interest in this building. President Fowler replies thank you again Mr. Williams.

Community member Lavern Tsosie replies Hello, this is Lavern.

President Fowler replies go head.

Community member Lavern Tsosie replies Hi Gloria, this is Laverne. I was in the same meaning as last year in March. This is called Echo Cliff Health Center, right? And I think this is right by their preschool up on top of gap on in N21, and it looks like it was requested for seventy-two thousand square foot and at seventy-five acres, that was the first approved. Now, you're asking for an additional ten acres, and that's gonna allow cafeteria and I think we also brought up, housing if that was going to be available for physicians and clinical staff to live out there at the area. Which was going to expand acreage and a hundred and fifty-two million dollars. Now, my other question too is I know a lot of physicians and clinical staff are probably going to be rotating in between clinics, between Page, Inscription House, Kaibeto, Tuba City and now this area. My question is, is that road from Kaibeto to first windmill gonna have to be paved to make it easier and to not complicate the staff members to travel all the way around Tuba City or Page just to get to this clinic? Have they even discussed that? And who is this really under or like Jerry said, is this under Gap or Coppermine? Because any building or infrastructures, that's like that, it requires a fire station. Is there's a fire station also included?

President Fowler replies thank you for the question. Do you have an answer Glenna Manymules-Bitsuie?

Glenna Manymules-Bitsuie replies yes, thank you for your question. The location that Mr. Williams ask about is almost a mile north of that Gap primary school. It's going to be a little way not too far, where the highway use to end. It's under Coppermine chapter District, it's under their jurisdiction. That's why we keep going back to Coppermine chapter. You asked for resolution, reaffirmed, how many times has it been reaffirmed for that particular site. Question Number three, you ask a by GMIC. One of the things that, I cannot talk for the corporation, you asked about Page. We are having a steering committee meeting on the twenty fourth of this month, that's next week. I can always bring it up to, if the building is already there. Because there's six thirty-eight, they're independent, they have their own funding and all that stuff. It might be easier for them to obtain that property and run a clinic from there, I can't say, because it's not my place to say. Thank you for bringing it up, it's something to think about. As for as housing, Laverne, my name is Glenna. Housing started at 72, then 82, now there's going to be 92 staff quarters. Yes, we are still going through the process with the Navajo Nation Council to approve name changed to Echo Cliffs. Because of COVID there's been a lot of things happening. It has to go through my office Navajo Department of Health, we have an individual lady that takes care of all the resolutions and goes to Department of Justice. They look at the resolutions and everything, it's a process. It takes a little time, and we still plan on changing the name. You asked about the funding, when the project was first approved in 2008, this project was only going to cost 31 million, can you believe that, the latest, Indian Health Service, five year plan budget March 2020 this project is going to cost \$151,200,000, so far. It's another year before we start the construction. This price will lock in once we start the construction, if the price of lumber or steel continues to go up, the price will go up. It changes from year to year. The funding for the road is not part of project between Kaibeto and First Windmill, it's not part of the project, but, I know Kaibeto is every interested in paving the road, they just need to look for funding to pave that road. This is something to talk to your Council Delegate about. You did ask about the fire station. We will have, it's not a fire station but it will have fire flow protection. The project is going to have its own individual water tank on the property so they will have water in there all the time incase there's a fire. With most of the projects, because NTUA does not do that kind of service, so we have to have our own water tank for fire protection. I think those were the questions.

Community Member Laverne Tsosie replies thank you.

President Fowler replies thank you for the questions and the update.

Glenna Manymules-Bitsuie replies Lola has a lot of information as well, you can quiz her. She probably has more information than I do. Thank you so much.

b. TCRHCC- Radiation Exposure Screening - Natasha Begay

Natasha Begay states Hi, hello, good evening, this is Natasha Begay. Thank you for having me Chapter Officials. So, my presentation is about the Radiation exposure screening education program that is offered at Tuba City Regional Health Care Corporation. This is a brand-new grant that Tuba City has obtained. It's a two year grant, so, the purpose of our grant with Tuba City is based off of their Radiation exposure Compensation act which they call RICA, it was amended back in the year 2000. The purpose is to help individuals that were exposed to radiation from the two hundred Nuclear testing that were done in Nevada. Nevada testing sites during the year of nineteen forty-five to nineteen sixtywwo. The Grant also offers radiation screen for all eligible down winders. Down Winders are individuals who resided in Northern Arizona during the years of nineteen fifty-one through nineteen fifty-eight, or duuring the month of July nineteen sixty two. So, we're out raising awareness about radiation exposure, and encouraging our elders to get checked for early detection. Come in for screening. They're of age to file for a RICA claim. We do have a patient navigator with the grants who we will be assisting individuals to complete their radiation claimed. Yeah. So, the RICA, the Radiation exposure Compensation act. The reason behind our urgency is because next year, next summer of July twenty two, is the deadlines for any kind of compensation to be file or any kind of claims to be filed. I understand that, Greg Stan of Arizona has, proposed to extend the deadline, but that has yet to be approved. We're looking at a deadline, of July twenty two. The compensation act, if you don't know Congress's compensating, individuals that were either onsite participant during the onsite testing,

downwinder which are everyone who resided in Northern Arizona, Southern Utah during the time of the testing. Also, uranium miners, uranium Miller's or transporters. So, if you were employed with any kind of uranium mining company during that time in the nineteen three two, they are compensating the minor workers. This grant has been fully supported and actually is provided on the medical side by Frank Dalla Cheil, our Hematology, our medical oncologist there at Tuba City, Regional Health care corporation. As you know, the specialty care center is what they're calling the cancer center there in Tuba City, has been open since May 2019. Frank Dalla Cheil and his wife Johanna DeMento are the providers that are completing the radiation screenings. The screenings include blood work, stool work, any kind of lab work and urine analysis, and on top of that they asked in an in depth questions about where did you grow up, your employment history or social history so they can kind of get an idea of how you may have been exposed to uranium and based off of that they will order necessary tests or family history they'll look at that as well. So, there are qualifying medical conditions so, there's a list of cancers, that are considered qualified diagnosis to be compensated. If you visit a Tuba City Regional health care's website, we do have a website that lists the cancers that are considered under the RICA claim where you can get compensated. If you go to our tuba city Regional Health Care Corporation website, visit radiation screening clinic radiation screening, the list of diagnosis will be there. We are offering screening clinics every third Thursday of the month. Our clinic has been advertised through Northern Arizona on KTNN, KUYI, printed in the Navajo Times, as well as the Navajo Hopi Observer. We're actually booked for the next three months, so we have provided three clinic date March eighteenth, April fifteenth as well May twentieth. At this time, those clinic dates are completely booked, so, we're booking out into the next month, so, that would be into June, July, August. Although the clinic dates are booked out, our office is open. You can call our office for any questions, or to book an appointment, 9282831802 or 9282832939, once again, my name is Natasha Begay with the Radiation exposure screening program. Our patient navigator her name is Saraphenia Thompson and she's a locally from Tuba city, Arizona. This is a HRSA funded grants, and I just want to stress to the community that deadline is approaching as of next summer they will stop compensating, for down winders, so we're trying to assist everyone, or even individuals who have pending claim, maybe they did not provide enough documentation or they are struggling to get some kind of proof of present. Call us, we can try to help you or if you had submitted your claim and haven't heard back from the department of Justice we can step in and help and get some answers for you. So, this program has it been around for over ten years and in the Northern Arizona because there's an office in Flagstaff as well as an office in Shiprock. The reason why Doctor Dalla cheil was passionate about bringing the program here to tuba city was because he doesn't see the reason why, our patients are traveling to Flagstaff or going out of their way to shiprock to file claims and to get the same kind of services that they can be, they can come to Tuba city for so, on top of that he has a big concern for the abandoned uranium mines around tuba city, in Cameron and Bitter Springs. And that is a main concern is to see if, people can get compensated that downwinder that are really affected by, nuclear testing that were done in nineteen forty two or the mining that was conducted in eighteen forty two, that's the passion behind that. Do I have any questions? Is there any questions?

President Fowler replies thank you again for telling us about your services.

ESCROW Funds, in PFD it states for certified and non-certified chapters, how the process to utilize these funds. I didn't know what ESCROW Funds were when you guys were talking about it, so, I asked Robert Black, he explained what it was. We'll see you Thursday.

b. Chapter Officials - PPE Distribution

President Fowler talks about the ESCROW Funds, Former Bennett Freeze area, electric line and bathroom addition, and use of the Chapter funds. What kind of work was done, and what money was used? All this work wasn't finished and that's what I am asking. I am working at visiting homes and make assessments. Any questions?

Annaretta Littleman replies hello, what is your name again?

President Fowler replies Allen Fowler Jr.

Annaretta Littleman replies I call them during the planning meeting for Kee K. Boone and Annie littleman. Is he person that is speaking is that the person that I would be speaking to? President Fowler replies yeah, I will be looking at the projects because we don't have a CSC now, and I'm pretty skilled at building houses, and as the Chapter President I want to know how the community housing situation are and update people on it and we can see what we assess and we can look at the budget and how we can help the community with that so without the CSC, I'm going to just go around and do my duty as the president and look at the projects because I know construction, so I can look at it, plus the ASC overlooks us because we don't have a CSC so we're working with ASC on that until we get another CSC. Does that answer your question?

Annaretta Littleman replies so Wilford Lane replaced or because that is who was helping us in our home.

President Fowler replies he resigned and that's what I'm saying, we're working with ASC in Tuba City, Milford Maloney and we're going to have a meeting on that, so that's where we are at with the CSC, but, as chapter president I going to go around and assess peoples house, and for my personal information and if anyone is buying, and that's why I look at the budget to see what kind of budget and ask what kind of budget we can use to help the community with their housing needs. Does that answer your question? Anyone else have any questions?

Annaretta Littleman replies yes.

VP Lola Smith states thank you, Mr. President. And Honorable Begay if you're still on the line, and Mr. Jerry Williams, Grazing Official and also Chapter Secretary. A lot of my report was done my Ms. Manymules-Bitsuie but here at the chapter, we will have a PPE Distribution, we're thinking Thursday 11am, beginning at 11am, because we have a meeting at 9 with water and also on that day, Thursday, we will have a box of veggies out of Tuba City, so we will have two distributions at the same time. Thursday at 11am so come by, tell your neighbors, people that live in Coppermine. Thank you. Secretary/Treasurer Delores Dempsey replies no, I don't have report today, thank you.

c. Grazing Official

Stanley Fowler states hello, I did some branding around the Coppermine area with some community people. They work for Branding Guns, only thing I don't have is branding iron, hopefully, Paul Begay can give me some branding iron. I did some homesite lease for some people and some proposed ones, and did some in Cedar Ridge, they don't have a Grazing Official. I'll be traveling around with Neal John Sr. to help each other out. Also, I was contacted by the water department Earth and Dam, Tommy Smith. We have a resolution to do the project, we have six of them have been proposed in 2016. He will be bring his crew around in about two weeks, I will be traveling around with them to show them where the dams are. Meeting with BIA for permits and training on Friday, we were updated on permits and land. Navajo Nation is still in the red code. Western Waterline Project set up a meeting for Thursday. Western Agency Grazing Committee meeting was yesterday, it was our district meeting, we still have same problems, nothing new. That's my report. Thank you.

Community member Delbert and Natalie Tsinnijinnie replies I have a question for the grazing official. Calvin didn't even do our tally; we didn't get any report or document that said he did. We saw him during the New Year, he said he would come by, he never came by. He didn't do last years. We

depend on that for our income to that's why we know it get report back to Coconino. I don't know why he didn't come by. Thank you.

LDA – Jerry Williams is speaking of burial grounds and public cemetery, audio is unclear.

 CHR Susie Shorthair replies hello, my name is Susie Shorthair, my work is CHR with LeChee Chapter,
 Coppermine Chapter. I go visit the elderly and I have about 65 elderly and I also have LeChee's, so all
 together I over 100 that I visit and I do visit them, make sure their ok, I tell them to stay home, if they
 need to go somewhere I tell them they need to wear a mask, and I informed them of the vaccine. I
 encourage the elderly to get vaccinated, and make sure they get their second dose. Then we were told
 that those that haven't been gotten their first vaccine make them appointments. I used to do the vital
 signs, but due to COVID I don't do it anymore. I also give them food boxes. Some of the elderlies that I
 visited need home renovations, bathroom additions, etc. I heard Allen is going to visit homes. These
 people don't have the money to do renovations. If anyone needs mask, let me know. We are taking
 applications for home healthcare if you want an application let me know. I even have applications for
