## RESOLUTION OF THE COPPERMINE CHAPTER

**SUPPORTING AND APPROVING THE COPPERMINE CHAPTER SCHOLARSHIP AND FINANCIAL STUDENT ASSISTANCE TO THE FOLLOWING (8) EIGHT FULL TIME STUDENTS IN THE AMOUNT OF \$400 EACH UTILIZING THE SCHOLARSHIP GENERAL FUND 13-6721 THE TOTAL AMOUNT OF \$3200 WILL BE UTILIZED FOR CHAPTER SCHOLARSHIP ASSISTANCE.**

### WHEREAS:

1. Pursuant to 26 N.N.C., Section 3, and 11 N.N.C. Section 10 the Coppermine Chapter is a duly recognized and certified Chapter of the Navajo Nation Government; and
2. Pursuant to 26 N.N.C., Chapter 1: Navajo Nation Chapters, Section 1., (B) (1) (2), the Navajo Nation Council delegated to Chapter governmental authority with respect to local matters consistent with Navajo law, including custom and tradition and allow chapters to make decisions to govern with responsibility and accountability to community membership; and
3. Navajo Tribal Council Resolution CJ-21-21-53 established the Navajo Higher Education scholarship Fund and provided for its administration through the Advisory Committee of the Navajo Tribal Council Resolution ACA-63-53 which adopted the rules and regulations for the operation of the funds; and
4. The Coppermine Chapter has established guidelines for students requesting Chapter Scholarship financial assistance to fill out a Chapter Scholarship Application and follow its guidelines and stipulations which requires students to completely fill out the application and submit all required documents before a check is issued to them; and
5. The following students have completed the Chapter Scholarship Application and have followed its guidelines and are eligible to receive financial assistance from Chapter Scholarship General Fund:
