Join the Child Development Associate Certificate Pathway Program and take your first steps towards an associate's degree in Early Childhood Multicultural Education. Through the Tribal Colleges and University Head Start Partnership grant, we provide merit-based support including tuition, textbooks, stipends, professional development, and more.

Navajo Technical University (NTU) has developed a comprehensive CDA Equivalent program aligned with competency standards set by the National Association for the Education of Young Children (NAEYC). Our program aims to increase the number of qualified educators in Navajo, Zuni and surrounding federally funded Head Start programs serving indigenous children. This program will provide a solid foundation for individuals seeking professional advancement in Early Childhood Education.

The coursework of the CDA Equivalent program will cover:

- The importance of integrating a culturally grounded curriculum in early childhood learning programs.
- Working with families, schools, and communities, understanding the significance of observation and documentation, and employing various forms of assessment
- Participants will learn how to uphold themselves as early childhood professionals.

In our accelerated program, Early Childhood Multicultural Education courses have been designed to accommodate diverse schedules. CDA Equivalent participants can choose from three specialized boot camp options: perfect for full-time Head Start employees, working Head Start caregivers, and stay-at-home caregivers with enrolled Head Start children.

Upon successful completion of the required 15 credits, participants will be awarded a Naaltsoos Bee Anoosééł (Paper with Growth) Certificate of Course Completion. This certificate signifies the participants' initial step towards potential career advancement in early childhood education. With this certificate, participants qualify to apply to the relevant educational offices in New Mexico or Arizona to obtain their official state-issued CDA certificate. Throughout the process, student-teachers will create networks of support to receive continued guidance and encouragement as they navigate the CDA Certificate application process.

ADMISSIONS & REGISTRATION

General Admissions Requirements for Enrollment Check-List:

- **Completed Admissions Application**
- Official High School Transcript or Official GED Test Scores (In a sealed envelope)
- Official College Transcript for Transferring Student—in a sealed envelope to the Registrar's Office, P.O. Box 849, Crownpoint, NM 87313 or electronic transcript to Wanda Jimmie, NTU Interim-Registrar at <u>wjimmie@navajotech.edu</u>
- Tribal Enrollment Document (CIB copy)
- Social Security Card (copy)
 - Placement test (if applicable)

All required documents will be kept on file and you will receive an Official Letter of Acceptance upon completing your admittance.

Guidelines to Registration

Step 1: Admissions

An Admissions Assistant will be on-site to guide students through the NTU application process. (See General Admissions Requirements)

Step 2: Financial Aid

A Financial Aid Assistant will be on-site to assist students with the Free Application for Federal Student Aid (FAFSA) process, and additional student funding.

Step 3: TCU Partnership Grant Funding

Students enrolled in a bootcamp cohort qualify for summer TCU partnership funding and agree to maintain good academic standing throughout the CDA-pathway bootcamp program. Contact TCU Program Coordinator Thomas Yazzie for more information.

Step 4: Academic Advising

An Advisor will be there to go over ECME program requirements, and time sequence.

Step 5: Registration

Obtain official Spring 2025 Course Schedule from On-Site Admissions Assistant, to complete registration process.

TRIBAL COLLEGES AND UNIVERSITY HEAD START PARTNERSHIP

The TCU partnership provides merit-based financial assistance, ensuring that the TCU grant will assist in covering the expenses of your enrollment in the CDA-pathway bootcamp as long as the student maintains good academic standing and adheres to the student responsibilities. The Head Start programs affiliated with Tribal Colleges and Universities (TCUs) are instrumental in establishing career pathways in early childhood education for Native Americans while also addressing the staffing needs of tribal Head Start programs. This partnership between TCUs and Head Start reaffirms the invaluable role TCUs play in Indigenous education and early childhood development. Each collaboration is deeply rooted in the culture and language of the respective tribe it serves, while also strategically tackling staffing challenges within the early childhood sector by nurturing a new generation of skilled educators. The TCU partnership aims to support aspiring student-teachers in pursuing higher education, enabling them to attain degrees such as Associates or Bachelors in Early Childhood Multicultural Education. This initiative is geared towards ensuring a pipeline of highly qualified individuals ready to contribute to the workforce of Head Start programs.

Student Responsibilities:

- All applicants MUST complete the TCU Grant Application form, College Readiness Assessment and Navajo Nation Application
- Applications and relevant documents must be submitted using your NTU student credentials/email and your completed forms must be sent to your TCU Program Coordinator for filing, Thomas Yazzie (<u>thomas.yazzie@navajotech.edu</u>)
- Maintaining Satisfactory Academic Progress
- Participation in Professional Development Workshops
- Maintain Academic Integrity
