APPROVING AND SUPPORTING THE LISTING OF 20 NAMES OF RESIDENTS LIVING IN THE FORMER BENNETT FREEZE AREA (FBFA) IN NEED OF HOUSING ASSISTANCE TO THE COMMUNITY HOUSING INFRASTRUCTURE DEPARTMENT WITHIN THE NAVAJO NATION DIVISION OF COMMUNITY DEVELOPMENT DEPARTMENT FOR UTILIZATION OF THE FORMER BENNETT FREEZE ESCROW FUNDS IN THE AMOUNT OF \$216,408.48 FOR HOME REPAIRS AND RENOVATIONS @ \$10,820.42 PER HOME.

WHEREAS:


